Know All Men by These Presents: That in consideration of **Three hundred ninety nine thousand and no/100 (\$399,000.00)**, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Walter B. 

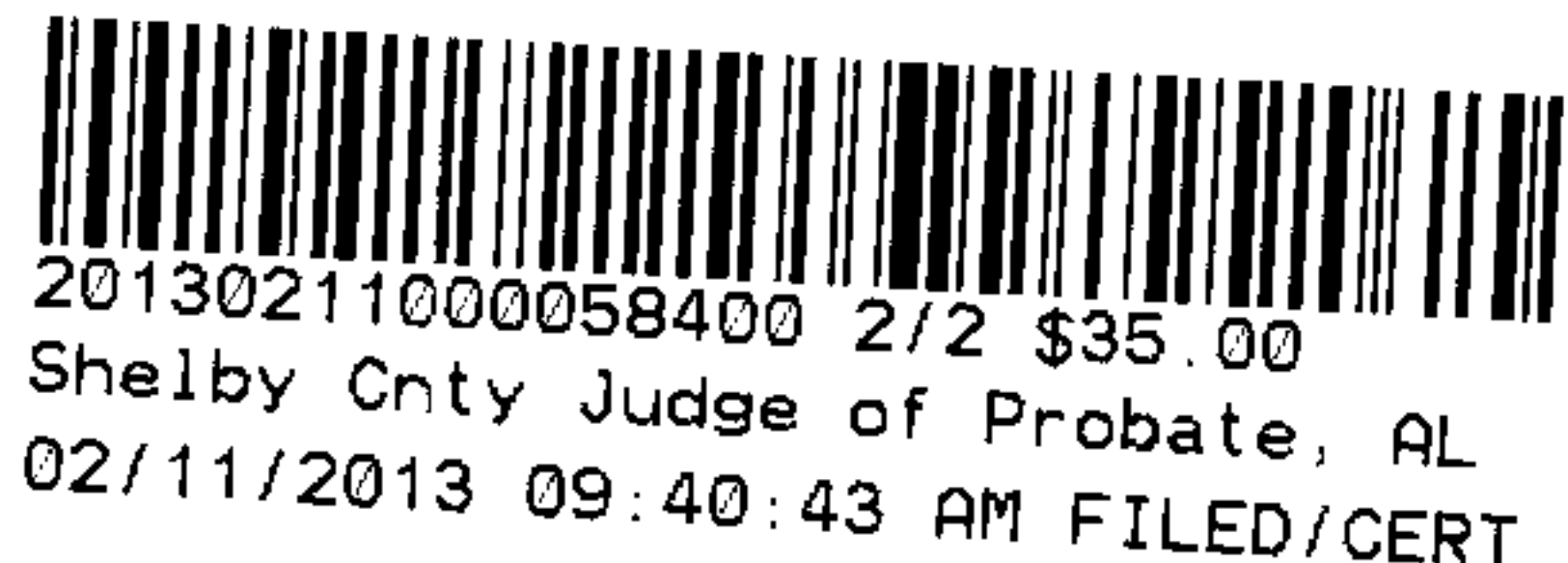
