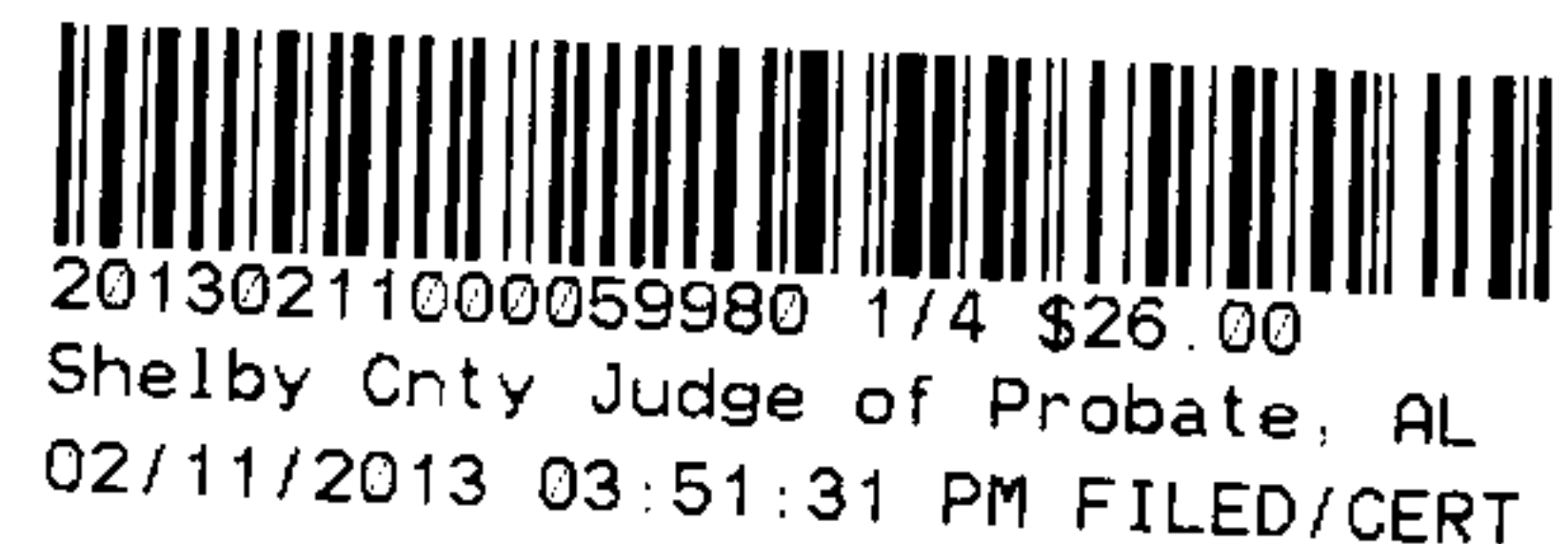

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That where as heretofore on February 4, 2009, Brad E. Lamb, a married man and Gabrielle Schmitt Lamb, his wife, executed a certain mortgage on the property hereinafter described to Mortgage Electronic Registration Systems, Inc. as nominee for Merchants & Farmers Bank., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, at Instrument No. 20090212000049040; and subsequently transferred and assigned to CitiMortgage, Inc., and said assignment being recorded in Instrument No. 20120703000234650; and

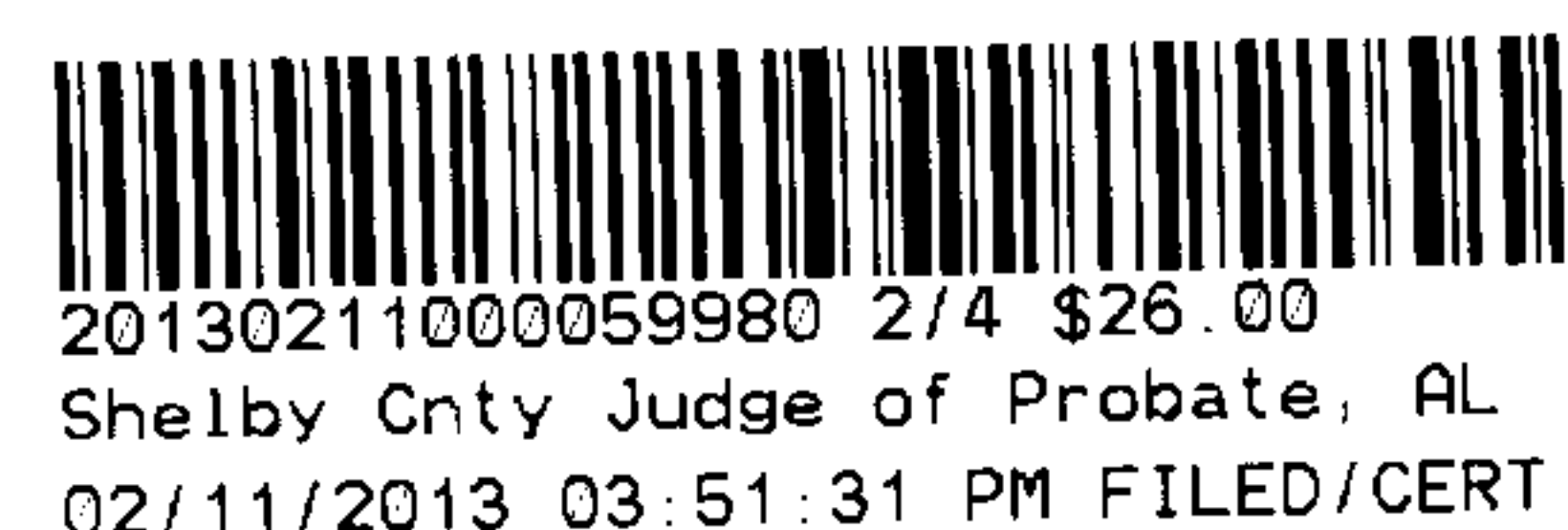

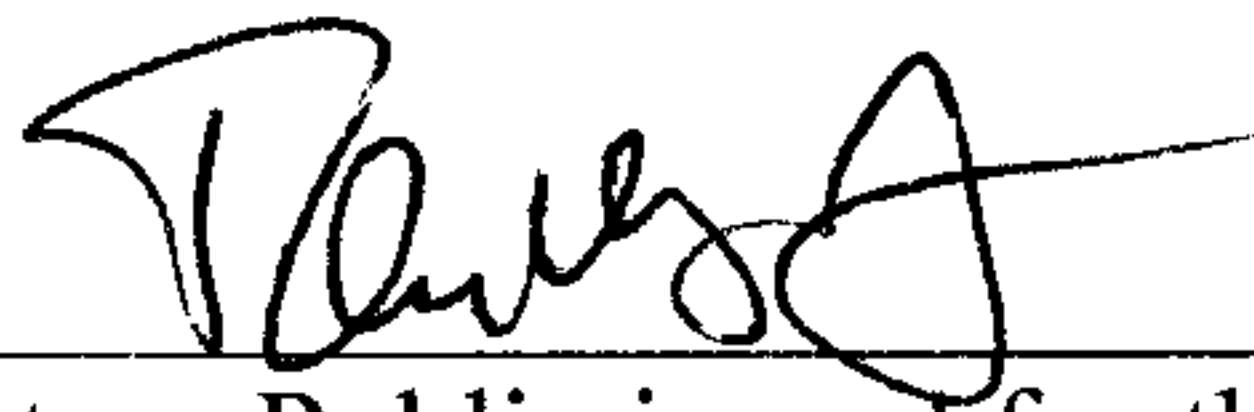
