KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 24th day of May, 2011, Elise Michelle John, an unmarried person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for RBC Bank (USA), which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20110527000157930, said mortgage having subsequently been transferred and assigned to PNC Bank, National Association, by instrument recorded in Instrument Number 20121017000399610, in the aforesaid Probate Office ("Transferee"); and

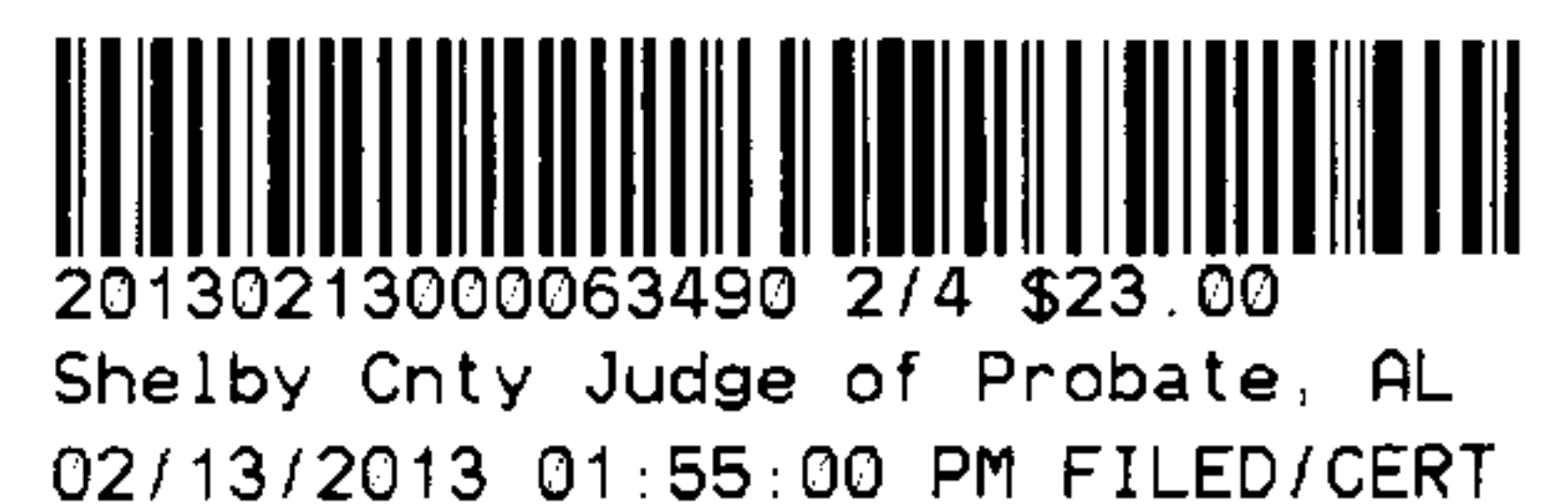
