Commence at the Northwest corner of Section 26, Township 21 South, Range 1 East; thence run Southerly along the West boundary of said Section 26 for a distance of 334.00 feet to a point; thence turn an angle of 89°47'23" to the left and run Easterly for a distance of 89.74 feet to a point, being the point of beginning of the parcel of land herein described; thence continue along the last described course for 310.26 feet to a point; thence turn an angle of 28°50'01" to the left and run 270.05 feet to a point; thence turn an angle of 76°38'12" to the right and run 76.17 feet; thence turn an angle of 11°02'15" to the right and run 137.80 feet; thence turn an angle of 7°57"30" to the left and run 113.70 feet; thence turn an angle of 2°22'35" to the right and run 57.16 feet; thence turn an angle of 34°32'11" to the right and run 114.55 feet; thence turn an angle of 9°00'51" to the left and run 114.00 feet; thence turn an angle of 47°27'16" to the right and run 61.68 feet to a point; thence turn an angle of 80°31'21" to the right and run 511.66 feet to a point; thence turn an angle of 29°04'45" to the right and run 135.00 feet to a point; thence proceed along a curve to the left having a central angle of 23°13'28" and a radius of 345.90 feet, for an arc distance of 140.21 feet to a point; thence turn an angle of 32°36'46" to the left, from the tangent to the curve, and run 109.97 feet to a point; thence proceed along a curve to the right, having a central angle of 66°24'55" and a radius of 25.00 feet, for an arc distance of 28.98 feet to the point of beginning.
