FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on November 26, 2001, to-wit: Paul Glenn Kendrick and Cari Lynne Kendrick, husband and wife, executed a mortgage to MORTGAGESOUTH, LLC, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on December 6, 2001, in Instrument Number 2001-53028, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which mortgage and the indebtedness secured thereby was subsequently assigned to Chase Home Finance LLC, by assignment recorded May 11, 2010, and recorded in Instrument Number 2010051100147700, of said Probate Court records; and




