**SPECIAL WARRANTY DEED**

KNOW ALL MEN BY THESE PRESENTS,

SHELBY COUNTY

That in consideration of Thirty-Four Thousand And 00/100 (\$34,000.00) to the undersigned, Federal National Mortgage Association aka Fannie Mae, a corporation, by and through Sirote & Permutt, P.C., as Attorney in Fact, (herein referred to as Grantor) in hand paid by the Grantee herein, the receipt whereof is acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Brian Wall, (herein referred to as Grantee), the following described real estate situated in Shelby County, Alabama, to-wit:

Lots 2 and 3, in Block 66, according to the unrecorded survey of J.H. Dunstan's Map of Calera in Shelby County, Alabama.

Subject to:

1. Any item disclosed on that certain policy of title insurance obtained in connection with this transaction.
2. Ad valorem Taxes for the current tax year, which Grantee herein assume and agree to pay.
3. Restrictions as shown on recorded plat.
4. All outstanding rights of redemption in favor of all persons entitled to redeem the property from that certain mortgage foreclosure sale evidenced by mortgage foreclosure deed recorded in Instrument Number 20130115000020450, in the Probate Office of Shelby County, Alabama.

These restrictions shall run with the land and are not personal to grantee.

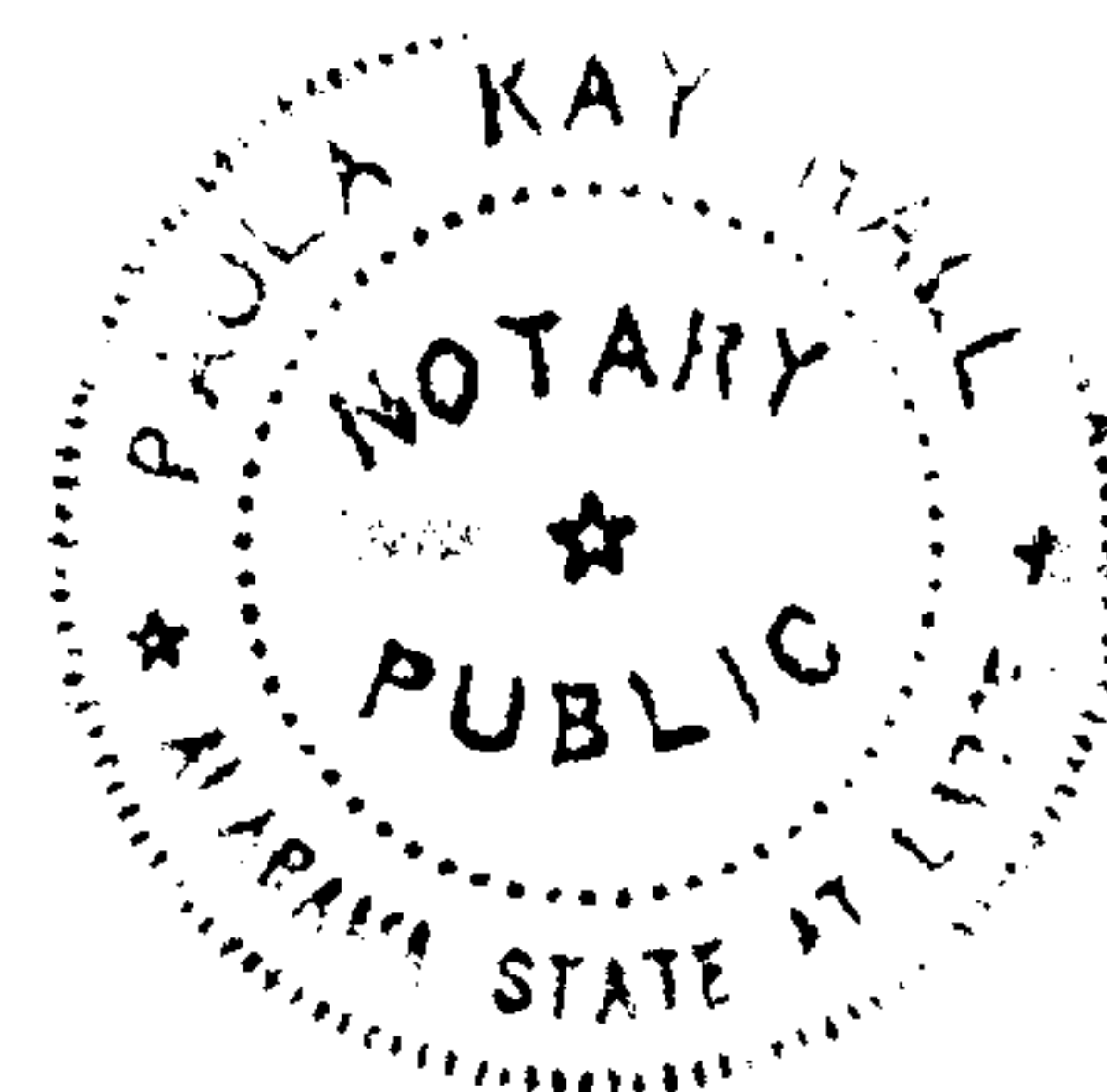


