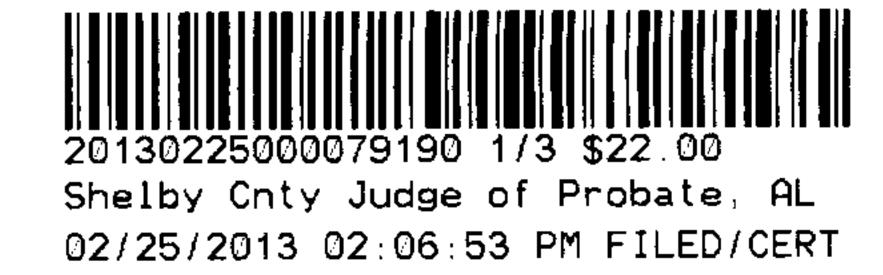

## MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on June 25, 2010, Billy Dawson and Tiffany Pulmas, Party of the First Part, executed a certain mortgage to Mortgage Electronic Registration Systems, Inc acting solely as nominee for NationStar Mortgage, LLC, its successors and assigns, party of the second part which said mortgage is recorded in Instrument No. 20100707000215850, in the Office of the Judge of Probate of Shelby County, Alabama.
