rights of dissenting members of IPSUM-AL.

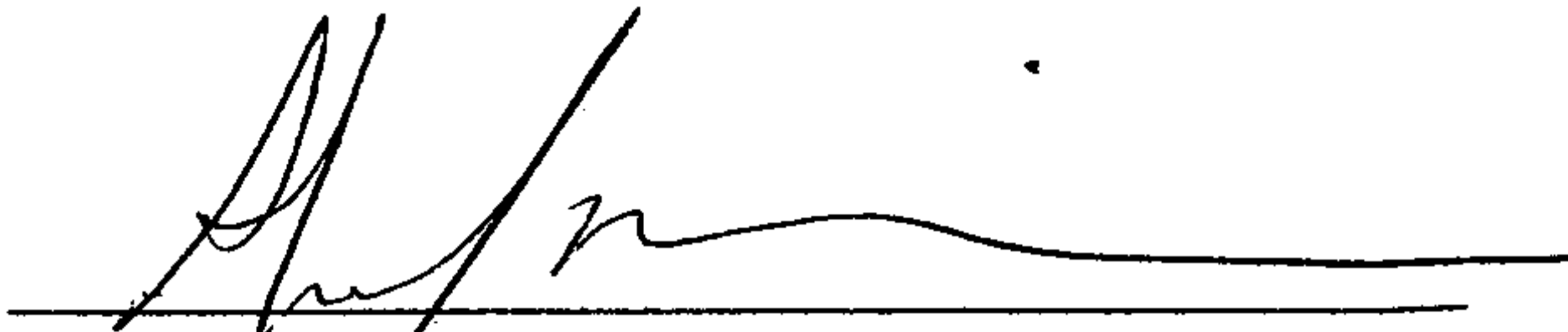
