\$164,000.00 of the consideration was paid from a mortgage loan closed simultaneously herewith.


TO HAVE AND TO HOLD, unto the said GRANTEE, her/his heirs and assigns forever.

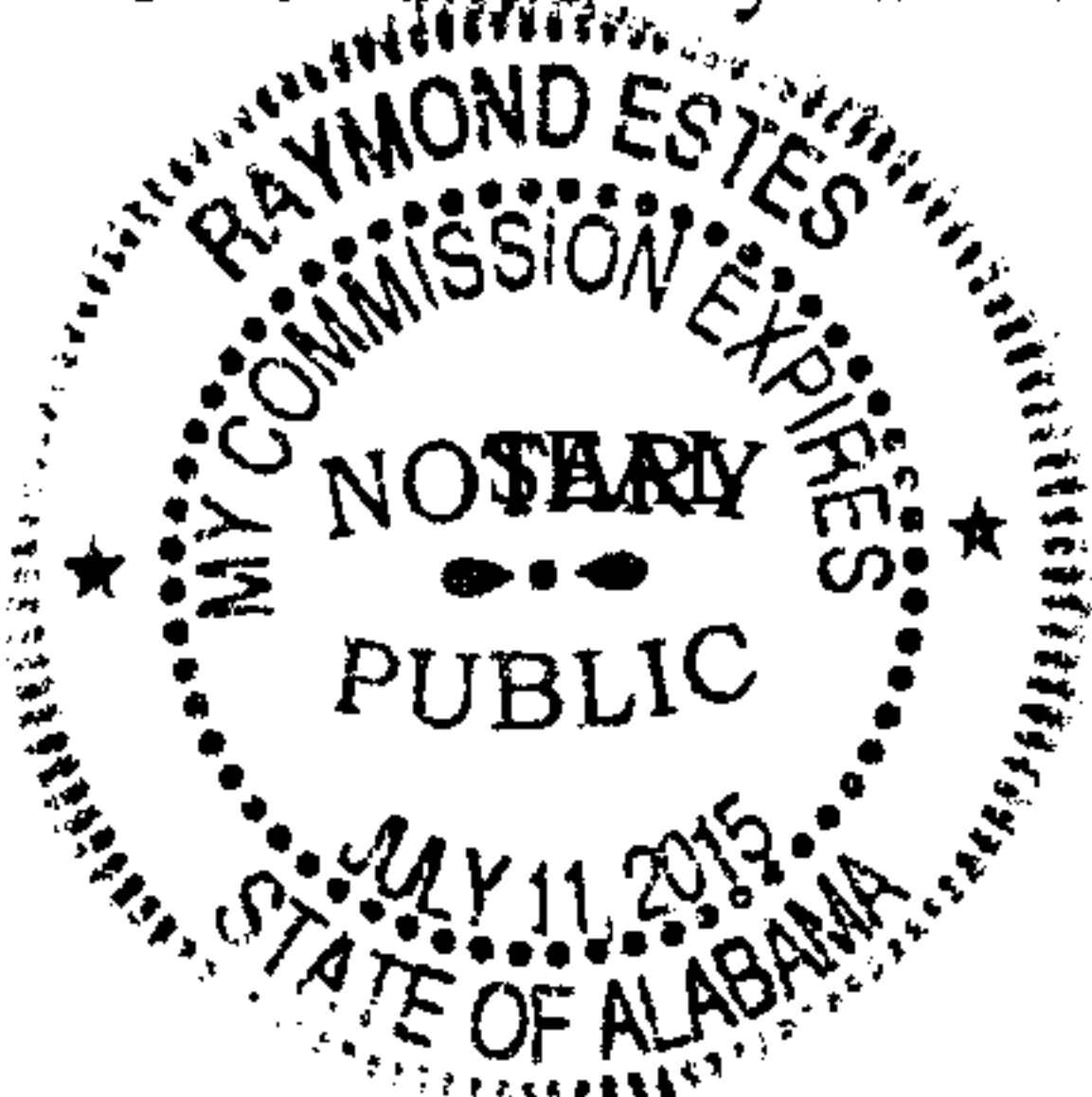
