FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on April 18, 2008, to-wit: Olen G. Hamrick and Paula Hamrick, husband and wife, executed a mortgage to NETWORK FUNDING, L.P., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on 4/28/2008, in 20080428000171480, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to Chase Home Finance, LLC, by assignment recorded 10/8/2010, and recorded in Instrument number 20101008000335250, Probate Records of Shelby County, Alabama; and
