Despite anything said in this Trust Agreement to the contrary, whenever RANDALL KEITH SISK is serving as Trustee, he/she may act alone in all matters relating to the trust including but not limited to removing and replacing trustees even though this Trust Agreement may refer to "Trustees" acting jointly. All powers of the Trustee are fully set forth in the trust agreement which created the Trust.

REVOCABILITY

4. While the Trustor is living, the Trustor may by acknowledged instrument alter, amend, revoke or terminate the Trust on thirty (30) days' notice to the Trustee (unless waive). The Trust has not been revoked, and there have been no amendments limiting the powers of the Trustee over the property of the Trust.

SIGNATURE AUTHORITY OF MULTIPLE TRUSTEES

5. When multiple Trustees are serving as co-Trustees of the Trust (except for banking which shall only require one Trustee's signature) the decision of a majority of the co-Trustees shall control in
