**ARTICLES OF ORGANIZATION  
OF  
Bishop Creek Land, LLC  
An Alabama Limited Liability Company**

Pursuant to the Provisions of Sections 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

**ARTICLE I**

*Name*

The name of the limited liability company is Bishop Creek Land, LLC, an Alabama Limited Liability Company (the "Company").

**ARTICLE II**

*Duration*

The Company shall have a duration from the date of organization until December 31, 2051, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

**ARTICLE III**

*Purposes*

The purpose for which the Company has been organized is to engage in the ownership, maintenance, use, and development of real property in the State of Alabama and to engage in any lawful act or activity for which limited liability companies may be organized pursuant to the Act.

**ARTICLE IV**

*Registered Office; Registered Agent*

The location and street address of the initial registered office of the Company shall be 120 Bishop Circle, Pelham, AL 35124, and its registered agent at such address shall be Jerry Robert Adams, Jr.

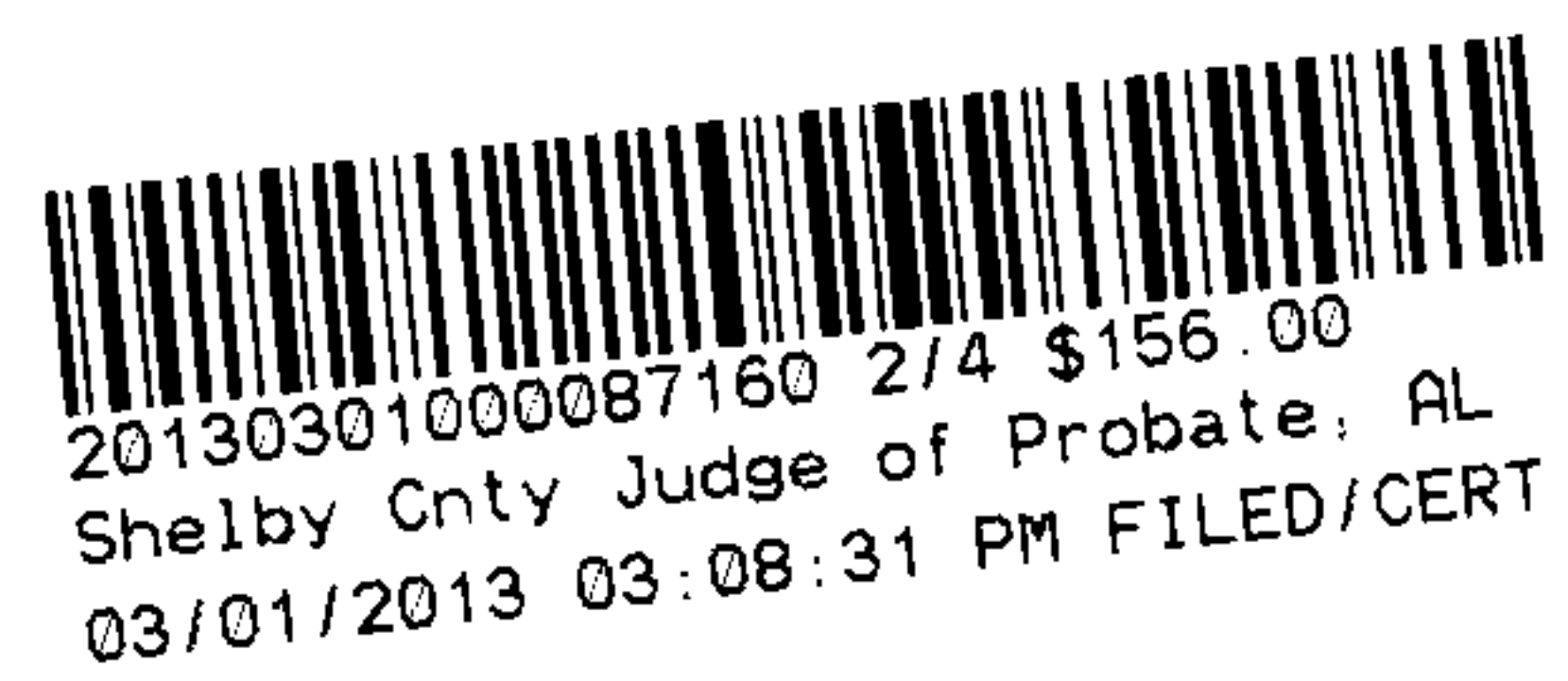
### *Admission of Additional Members*


## ARTICLE VII
