KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of October, 2005, Susan D. Green, divorced, executed that certain mortgage on real property hereinafter described to Household Finance Corporation Of Alabama, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20051012000530540, and

published in Shelby County, Alabama, in its issues of January 16, 2013, January 23, 2013, and January 30, 2013; and

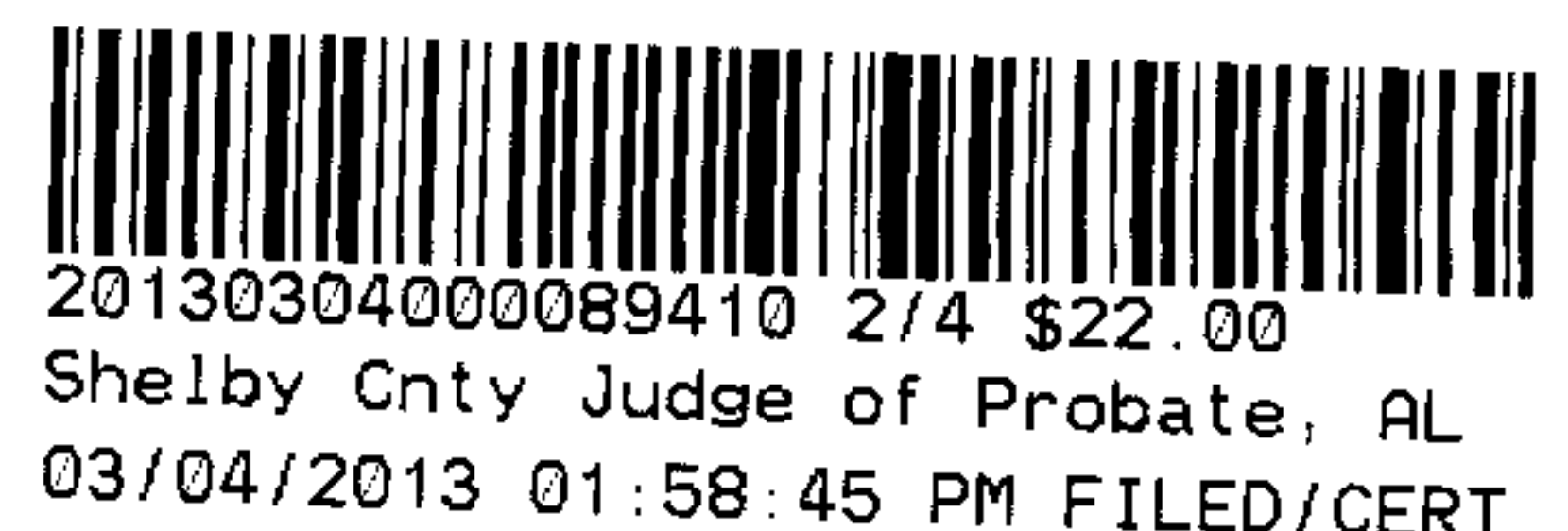


