Sheriff's Deed

Whereas, an execution issued from the State of Alabama Department of Revenue, against Tonja M. Sims in favor of State of Alabama Department of Revenue on a judgment rendered in said Court at the October Term thereof, 2012, for the sum of One hundred ninety eight thousand four hundred sixty two and 89/100 ----- Dollars, besides cost of suit, which said execution came into my hands, as Sheriff of said County, on the 30th day of October, 2012, to execute and return according to law; and, whereas, also, divers other executions issued from the n/a were also placed in my hands, against said n/a to execution and return according to law, as will appear by reference to the records of said court, by virtue of which execution above recited, as also the other said executions, I did, as Sheriff aforesaid, levy upon the following as the property of said Tonja M. and set over to the said State of Alabama Department of Revenue all the legal right, title, interest, and claim which the said Tonja M. Sims had and held in and to the foregoing described premises.


