

A parcel of land in the West Half of the NE 14 and in the East Half of the NW ¼ of Section 1, Township 22 South, Range 1 West, Shelby County, Alabama, described as follows: Commence at the Northeast corner of the NE ¼ of NW ¼; thence run West along the North ¼-1/4 line 611.49 feet to a point on the East right of way of the Old L & N Railroad spur; thence turn left 108 degrees 22 minutes 59 seconds and run Southeast along said right of way 1094.46 feet to the point of beginning; thence turn left 00 degrees 04 minutes 57 seconds and continue Southeast along said right of way 626.21 feet; thence turn left 104 degrees 25 minutes 15 seconds and run Northeast 409.63 feet to a point on the West right of way of Shelby County Highway #47; thence turn left 87 degrees 54 minutes 05 seconds and run Northwest along said highway right of way 568.74 feet; thence turn left 84 degrees 11 minutes 37 seconds and run Southwest 277.14 feet to the point of beginning.
