KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of February, 2007, Jeremy K. Collins and Deonna Collins, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Lehman Brothers Bank, FSB, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20070319000122230, said mortgage having subsequently been transferred and assigned to Fannie Mae (Federal National Mortgage Association"), by instrument recorded in Instrument Number: 20121210000473200, in the aforesaid Probate Office ("Transferee"); and

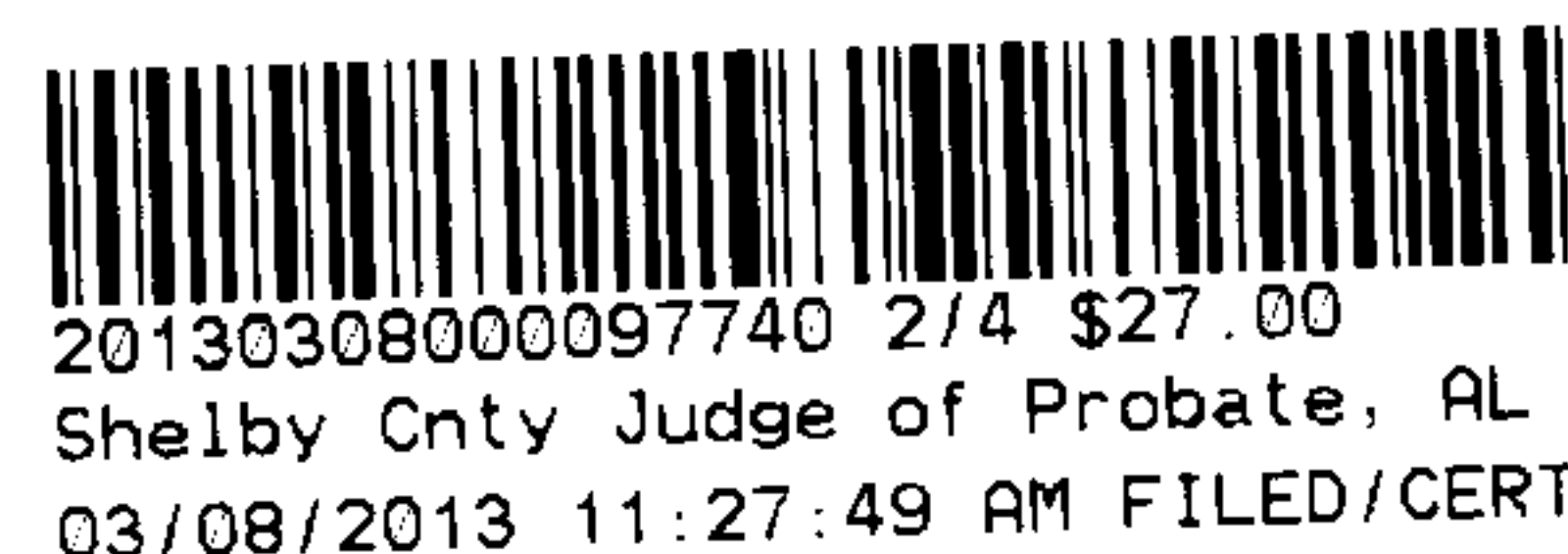

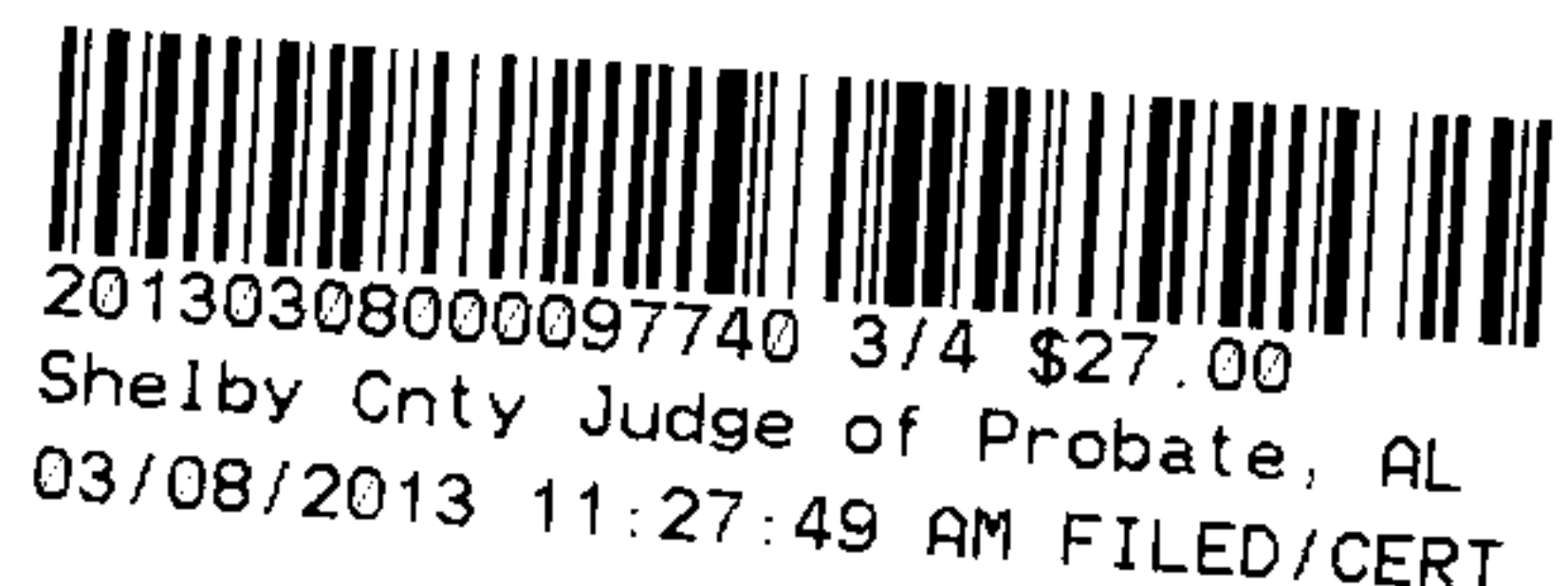
