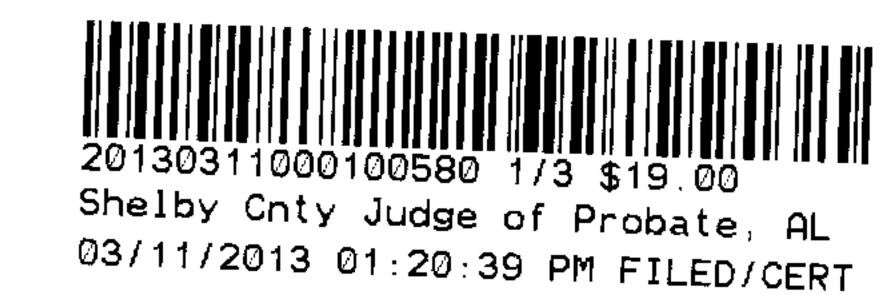

## MORTGAGE FORECLOSURE DEED

WHEREAS, heretofore on November 9, 2006, Jennia R. Hendrix and Stacey S.
