### AFFIDAVIT OF MISSING ASSIGNMENT

The undersigned Jimmie Hernandez, being duly sworn deposes and states as follows:

1. That I am a AVP of Wells Fargo Bank Minnesota, National Association, as Trustee for First Franklin Mortgage Loan Trust 2003-FFH2, by SAXON MORTGAGE SERVICES, INC., its Attorney-in-Fact having its principal place of business at 4718 MERCANTILE DRIVE, FORT WORTH, TX 76137, an officer duly authorized to make this affidavit.
2. That I have personal knowledge of the facts set forth in this Affidavit.
3. That Wells Fargo Bank Minnesota, National Association, as Trustee for First Franklin Mortgage Loan Trust 2003-FFH2, by SAXON MORTGAGE SERVICES, INC., its Attorney-in-Fact ("Current Mortgagee/Beneficiary") is the Mortgagee/Beneficiary of a certain Mortgage/Deed of Trust (the "Mortgage/Deed of Trust") dated on 08/11/2003 made by EMMITT B. THOMAS AND MARGARET W. THOMAS as Mortgagors/Trustors to FIRST FRANKLIN FINANCIAL CORPORATION as Original Mortgagee/Beneficiary, which Mortgage/Deed of Trust was recorded on 08/15/2003 in the office of the Recorder, Registrar or Clerk of SHELBY County, in the State of AL, in Book/reel, Page, and/or Document # 20030815000539980.

10. The Current Mortgagee/Beneficiary agrees to indemnify and hold harmless the Recorder, Registrar or Clerk of said County from and against any cost or claims that may arise by reason of the acceptance and recording of this affidavit.
