

ARTICLES OF ORGANIZATION OF GWB SHORT, LLC

The undersigned, for the purpose of forming a limited liability company under the Alabama Limited Liability Company Law, Title 10A, Chapters 1 (to the extent applicable to limited liability companies) and 5 of the <u>Code of Alabama</u> (1975), as amended (the "Law"), hereby files the following Articles of Organization and attests that the facts stated in these Articles of Organization are true and correct:

- 1. Name. The name of the entity being formed (hereinafter referred to as the "Company") is GWB Short, LLC.
- 2. Type. The Company is being formed as a limited liability company
- 3. <u>Purposes.</u> The Company has been organized for the purpose of buying, holding, acquiring, owning, selling, maintaining, managing, and otherwise dealing in assets and investments of any and all kinds. The Company may also transact any lawful business for which a limited liability company may be formed under the Law, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company, securities broker, securities dealer or investment advisor.
- 4. **Duration.** The period of the Company's duration shall be perpetual.
- 5. <u>Initial Registered Agent and Office</u>. The location and mailing address of the initial registered office of the Company is 27 Inverness Center Parkway, Birmingham, AL 35242, and the name of its initial registered agent at such address is George W. Barber, Jr.
- 6. Organizer. The name of the person authorized to act as the organizer of the Company is George W. Barber, Jr. and his address is 27 Inverness Center Parkway, Birmingham, AL 35242.
- 7. <u>Additional Members</u>. Any new or substitute members shall be admitted to the Company only in accordance with the provisions of the Law and the Operating Agreement of the Company as entered into among its members.
- 8. <u>Cessation of Members</u>. The cessation of membership of all members will result in the dissolution of the Company unless the holders of all financial rights in the Company agree in writing, within ninety (90) days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members.
- 9. Management. The Company shall be managed by one or more Managers. Each Manager acting individually shall have the right to execute any and all documents, to act on

behalf of the Company and to otherwise bind the Company. The names and addresses of the initial Managers are:


