

CERTIFICATE OF FORMATION

OF

Pursuant to the provisions of Sections 10A-5-1.01, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is PEEKS CONSTRUCTION, LLC (the "Company").

ARTICLE II

Duration

The Company shall have the perpetual duration unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Law (the "Law") or the Company Operating Agreement.

The purposes for which the Company is formed are:

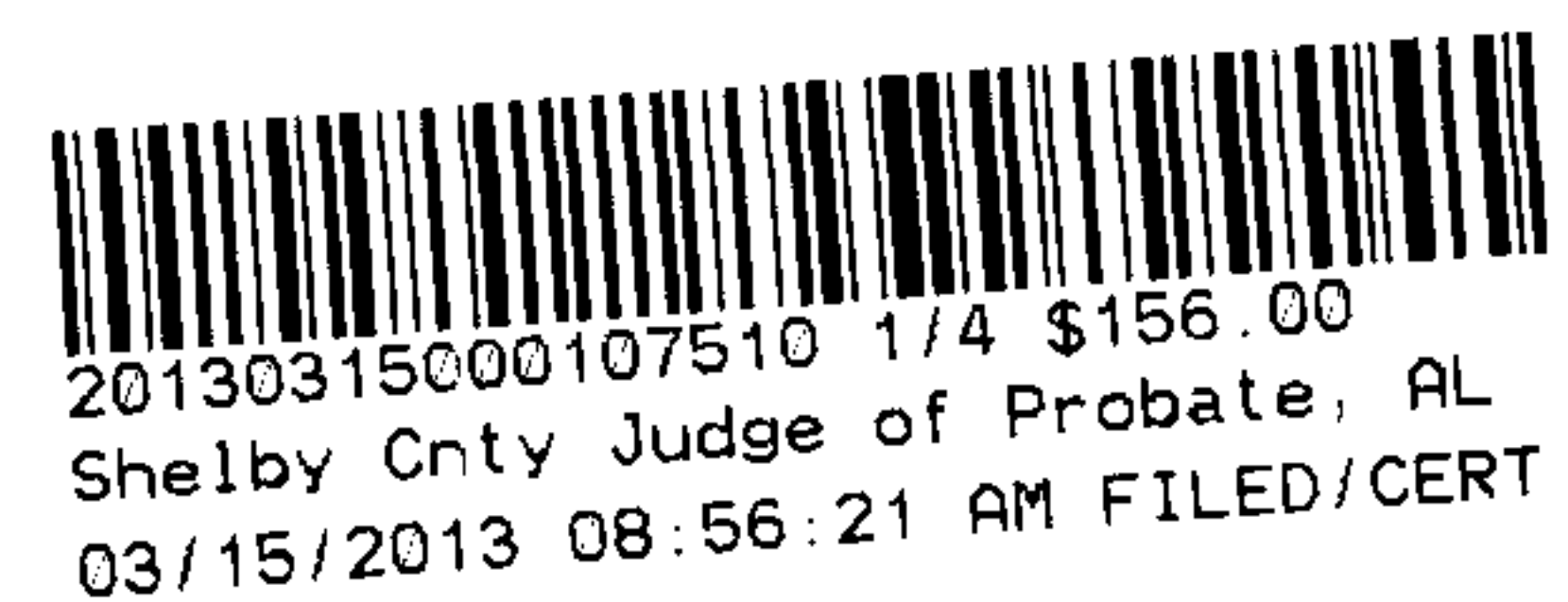
(a) To engage in the business of residential and commercial construction for profit, and to engage in any and all activities related to or incidental thereto;

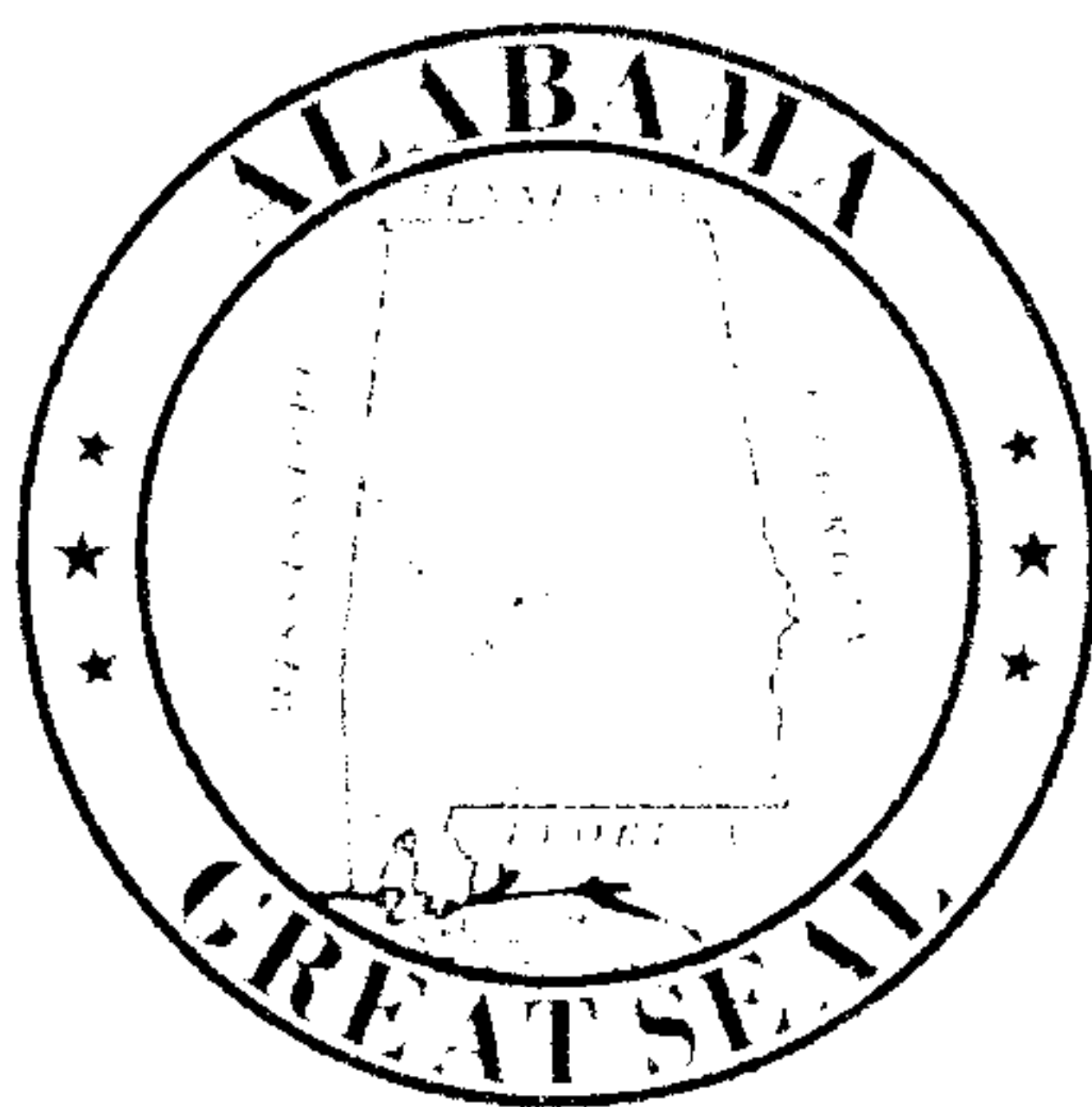
