Subject to taxes for 2013 and subsequent years, easements, restrictions, rights of way and permits of record.

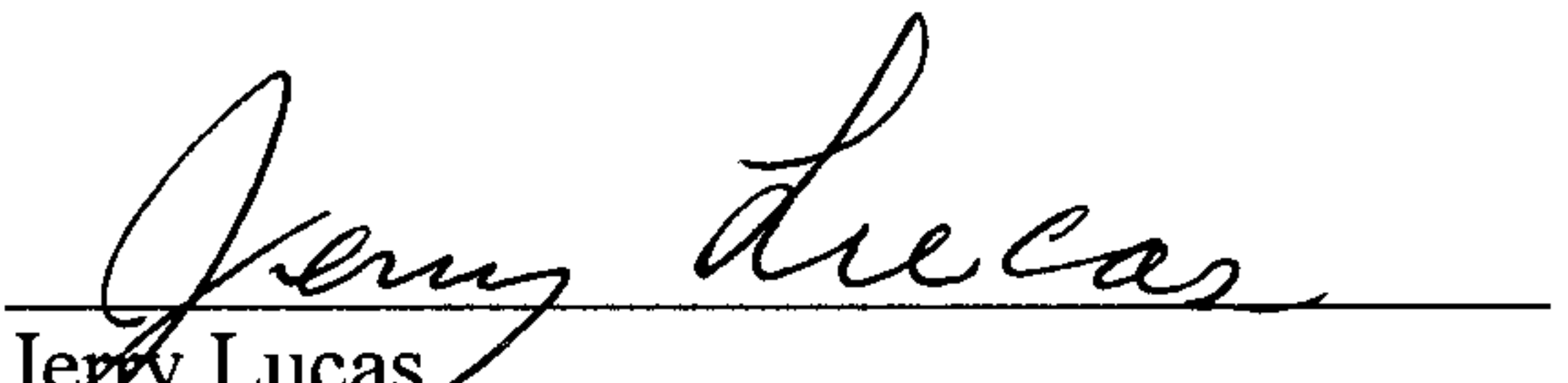
\$410,000.00 of the above recited purchase price was paid from a purchase money mortgage recorded simultaneously herewith.

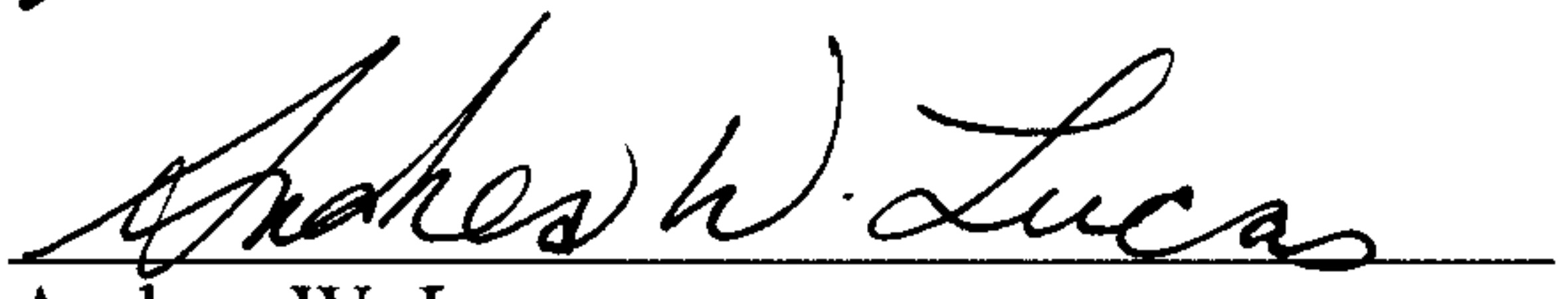

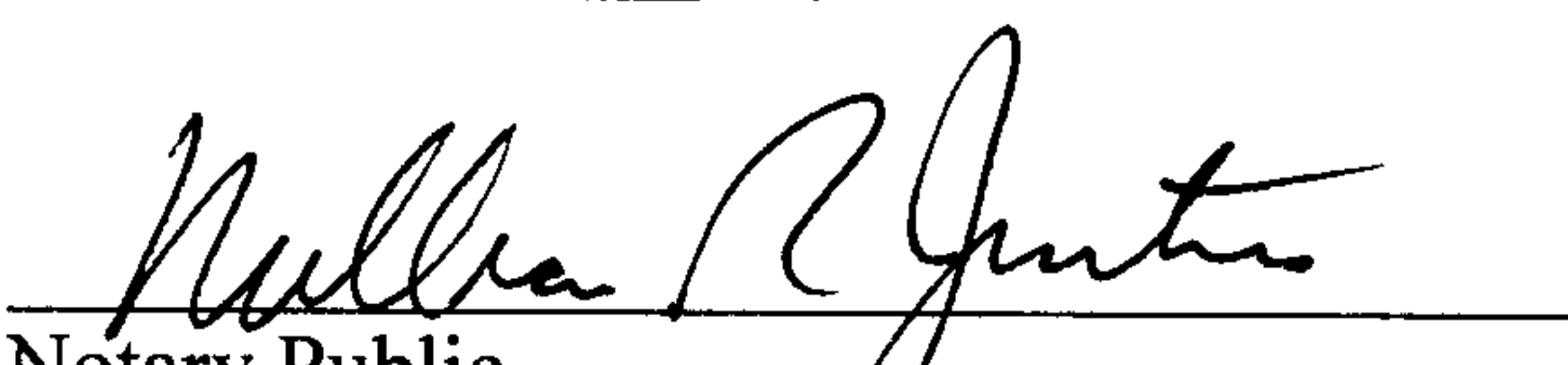
