## AFFIDAVIT OF JOSEPH S. BUSSEY

I, JOSEPH S. BUSSEY, being of legal age and first duly sworn, hereby depose and say the following is true and correct to the best of my knowledge:

- 1. My wife, Patricia A. Bussey, is the true and lawful owner, of a parcel of land, including a residence, located at 1012 Riverchase Cove, Birmingham, Alabama 35244, which is physically located in Shelby County and within the city limits of Hoover, Alabama. I reside with my wife at this location.
- 2. On September 8, 2000, the State of Alabama, Department of Revenue, filed a Notice of Lien for Taxes in the amount of \$1,432.65 for the tax period ending 12-31-1996, with the Jefferson County Judge of Probate, in Birmingham, Alabama, which was recorded in Instrument Number 200010/7323.
- Upon learning of the aforementioned lien I immediately traveled to Montgomery, Alabama, where the taxes were paid in full.
- 4. On March 1, 2001, the State of Alabama, Department of Revenue, filed a Release of Lien for Taxes with the Jefferson County Judge of Probate, in Birmingham, Alabama, which was recorded in Instrument Number 200103/0927 (see copy attached hereto).
- 5. During February, 2011, my wife and I decided to refinance our residence at which time the new lending company, J P Morgan Chase Bank, N.A., ran a credit check which reflected the old Alabama Department of Revenue Lien for Taxes. The lender was advised this lien had been satisfied in 2001. I obtained a copy of the Release of Lien for Taxes from Land Title Company of Alabama and furnished it to the lender, but became concerned that the Release of Lien for Taxes had been recorded in Jefferson County, Alabama, when, in fact, my residence is located in Shelby County, Alabama.
- 6. On February 23, 2011, I obtained certified copies of the Notice of Lien for Taxes and the Release of Lien for Taxes from the Jefferson County, Alabama, Probate Office and took them to the Shelby County, Alabama, Probate Office and had them recorded in order to clear up any questions that might arise in the future.
- 7. By inadvertently refiling the original Notice of Lien for Taxes in Shelby County, a new lien was created under Shelby County Probate Office Instrument Number 20110223000061960, even though it had already been satisfied as indicated by the

Release of Lien for Taxes which was filed simultaneously under Shelby County Probate Office Instrument Number 20110223000061970.

8. Subsequent credit checks reflect this new Shelby County lien, which was previously satisfied, to be outstanding which is adversely affecting my credit records.


