The undersigned, desiring to organize a nonprofit corporation under the laws of the State of Alabama, do sign and file these Articles Of Incorporation as follows:

FIRST

The name of the corporation is 316 Ministries, Inc.

SECOND

The corporation shall have all of the rights and powers provided for corporations under the laws of the State of Alabama as described in the Alabama Nonprofit Corporation Act. The primary activity of the corporation will be providing various ministry-related services to the population.

THIRD

The address of the initial registered office of the corporation is 121 Stratshire Lane, Birmingham, Alabama 35124 and the name of its initial registered agent at said address is Ronald J. Hester.

FOURTH

The period of duration of the corporation shall be perpetual.

FIFTH

The corporation shall not have members.
