
ARTICLES OF ORGANIZATION OF



SPECTRA SERVICES, LLC

Pursuant to the Provisions of Sections 10-12-1, et seq. of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is Spectra Services, LLC (the "Company").

ARTICLE II

Duration


The duration of the Company shall be perpetual unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III

Purposes

The purposes for which the Company is formed are:

- (a) To engage in real estate investment and management;
- (b) To purchase, take, receive, rent, lease or otherwise acquire, own, hold, manage, improve, rent, lease, use and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;
- (c) To engage in any industrial, manufacturing, mining, mercantile, trading, agricultural, service, or other lawful business of any kind or character whatsoever;
- (d) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, stocks, shares, bonds or other interests in, or obligations of, corporations, associations, partnerships, limited liability companies, limited liability partnerships, mutual funds, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;



- (e) To lend money, invest and reinvest its funds and take and hold real and personal property as security for the payment of funds so loaned or invested; and
- (r) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.

ARTICLE IV

Registered Office; Registered Agent

The location and street address of the initial registered office of the Company shall be 233 Crest Lake Dr., Birmingham, Jefferson County, Alabama 35244, and its registered agent at such address shall be James Billy Brooks.

Admission of Additional Members

Upon the unanimous written consent of the members, the Company may permit the admission of additional members and the terms and conditions of their admission shall be as set forth in the Company's Operating Agreement.

ARTICLE VIII

Continuation of Business

The Company may be reconstituted and the business of the Company may be continued following an event of dissociation which terminates the membership of a member of the Company if (i) the business of the Company is continued by the written consent of all of the remaining members within 90 days after the occurrence of the event of dissociation, and (ii) any other applicable requirements of the Provisions of Sections 10-12-1, et seq., of the Code of Alabama (1975) for the continuation of business are met.


