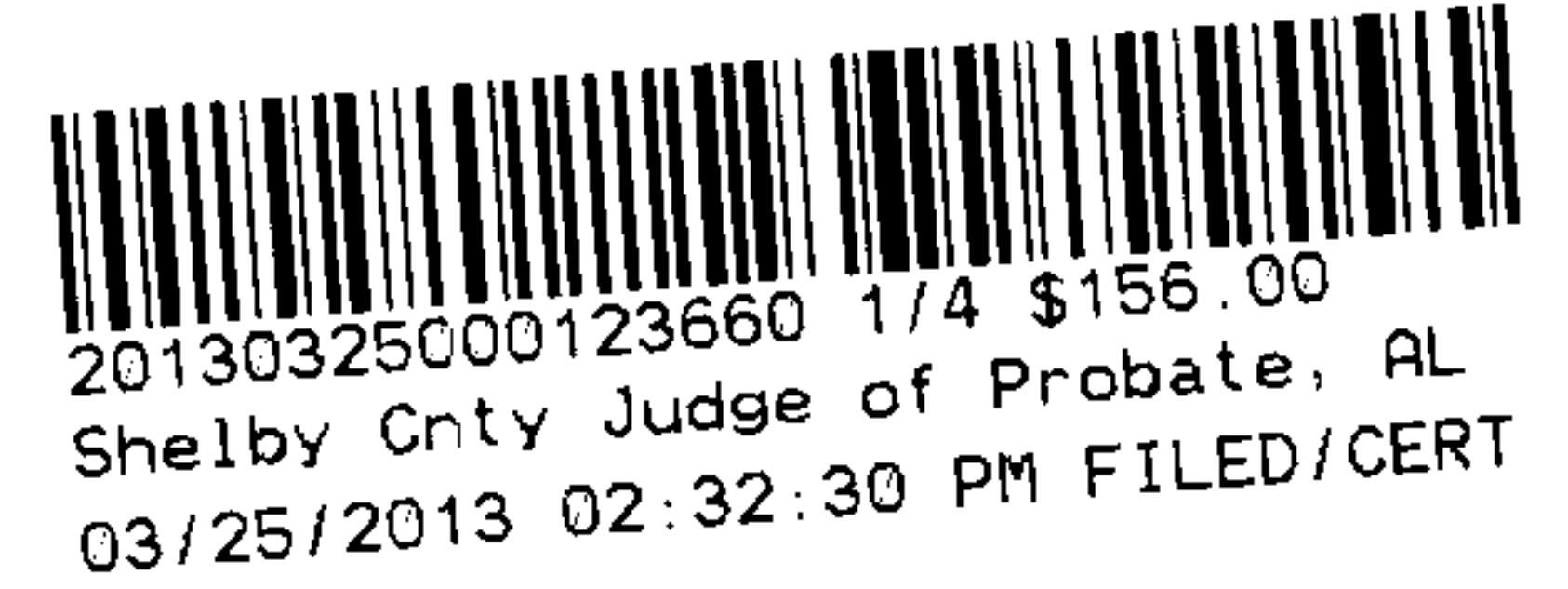

ARTICLES OF ORGANIZATION

The undersigned, a natural person over the age of eighteen (18) years, acting as Organizer of a limited liability company under the Alabama Limited Liability Company Law does hereby adopt the following Articles of Organization for such limited liability company.

ARTICLE ONE
NAME

DURATION

The limited liability company is organized for **selling donuts, pastries, beverages and other food items** and the transaction of any and all lawful business for which limited liability companies may be organized.


ARTICLE FOUR
