KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of January, 2008, Michael W. Eaton and Melanie R. 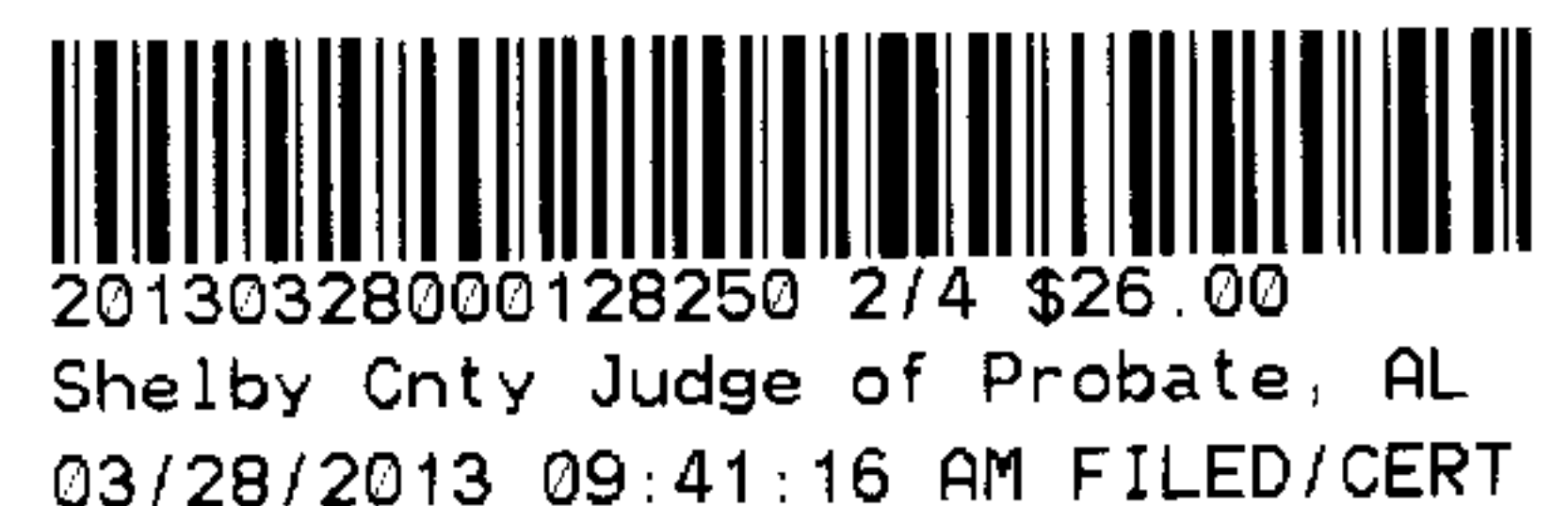
