KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 13th day of May, 2011, Linda Beamon, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Nationstar Mortgage, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20110518000149400, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage, LLC, by instrument recorded in Inst# 20121204000463370, in the aforesaid Probate Office ("Transferee"); and

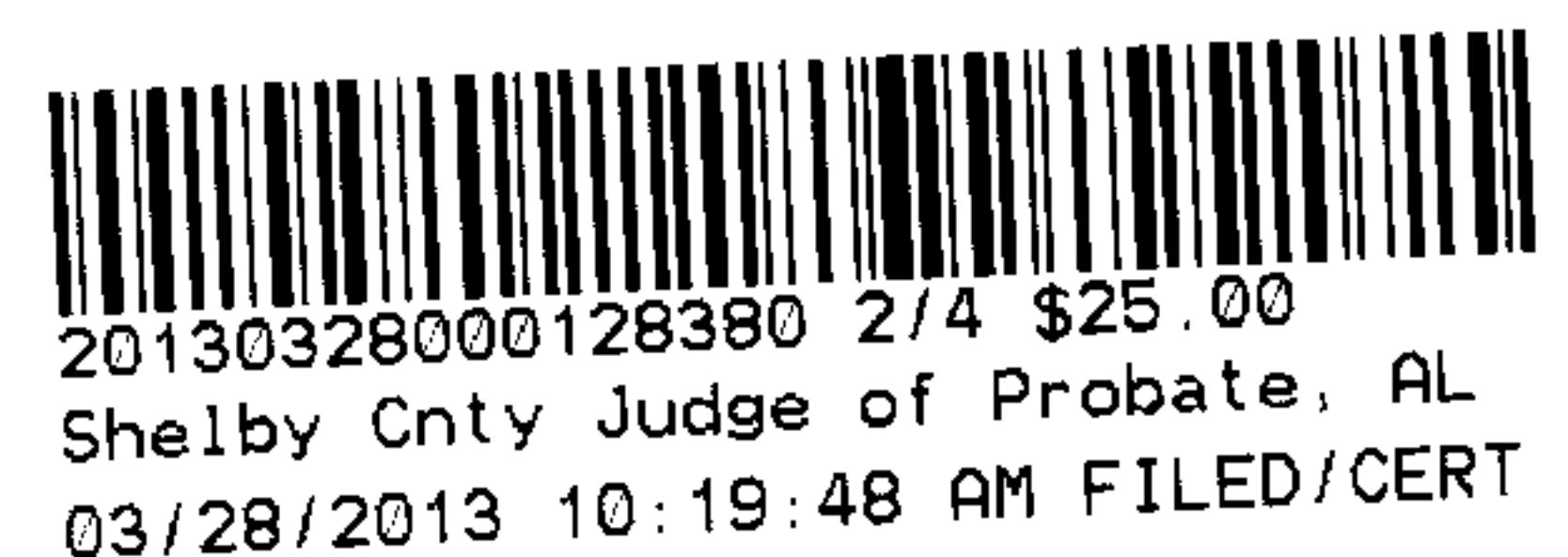
