

AUCTIONEER'S DEED

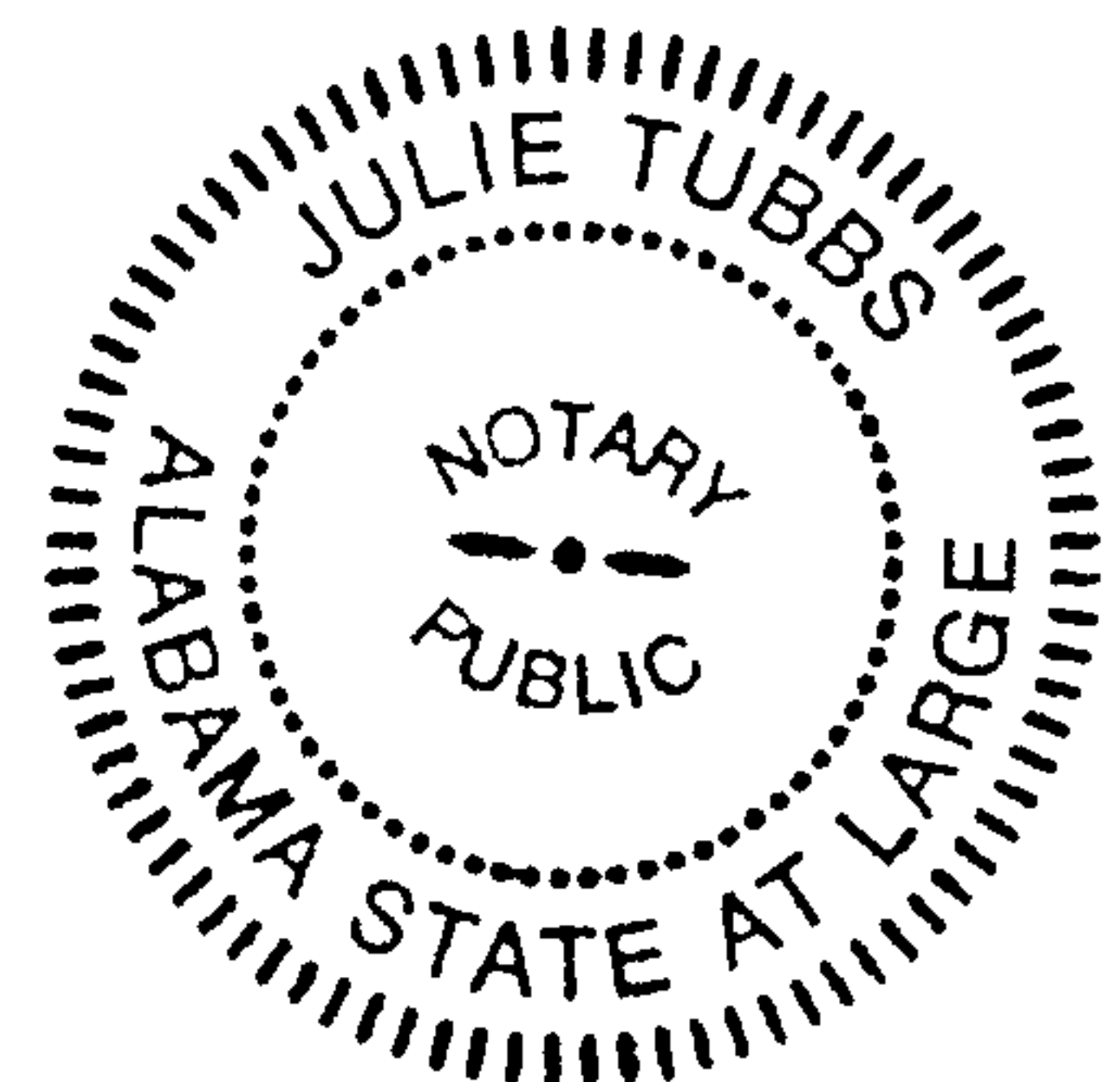
