
Subject to all rights of way, easements, covenants and restrictions of record.


Subject to current year ad valorem taxes, which are not yet due and payable.



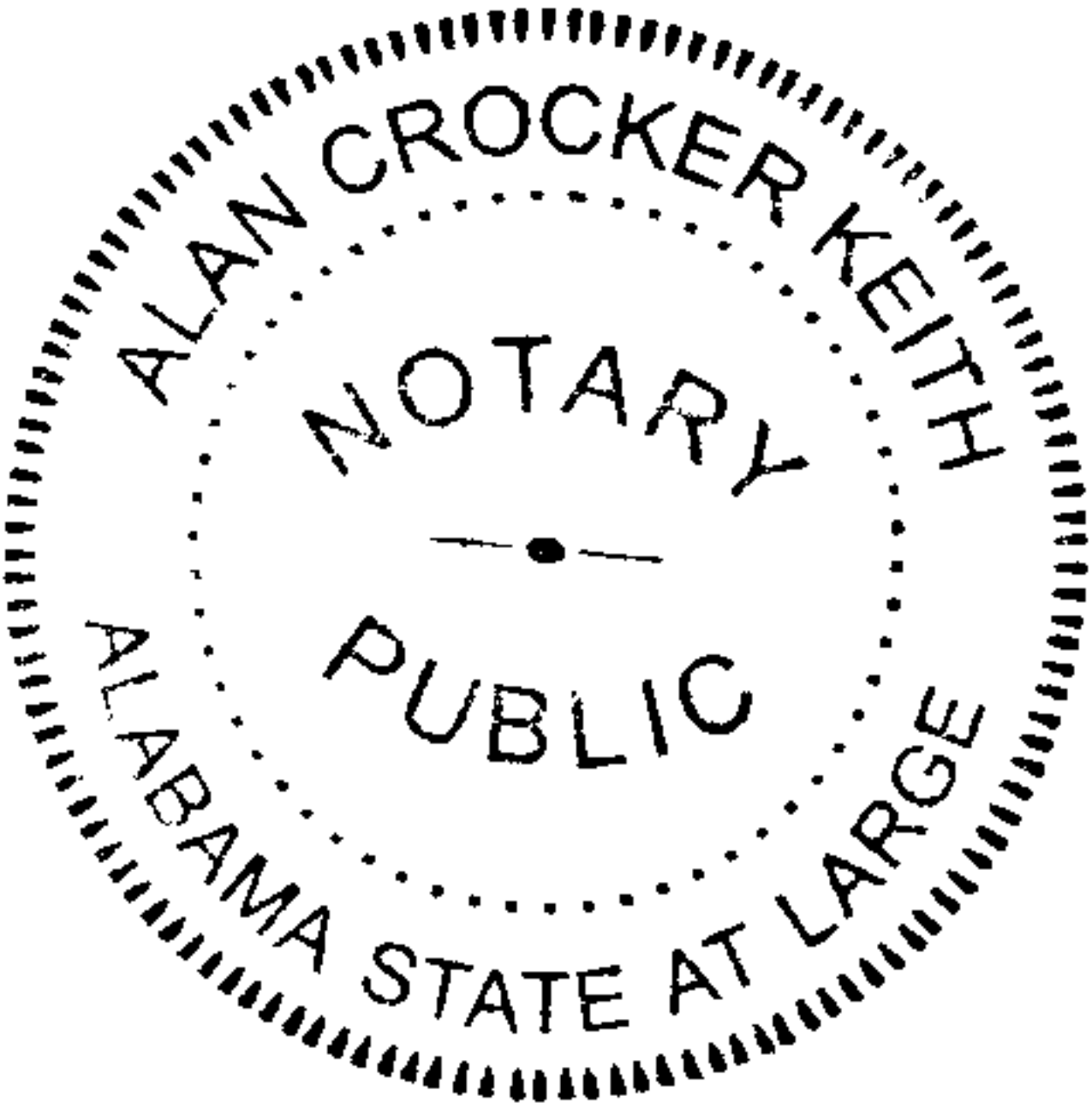
