KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, heretofore, on, to-wit: the 9th day of November, 2007, Eddie L. Keith and Anita W. Keith, executed that certain mortgage on real property hereinafter described to WELLS FARGO BANK, N.A. 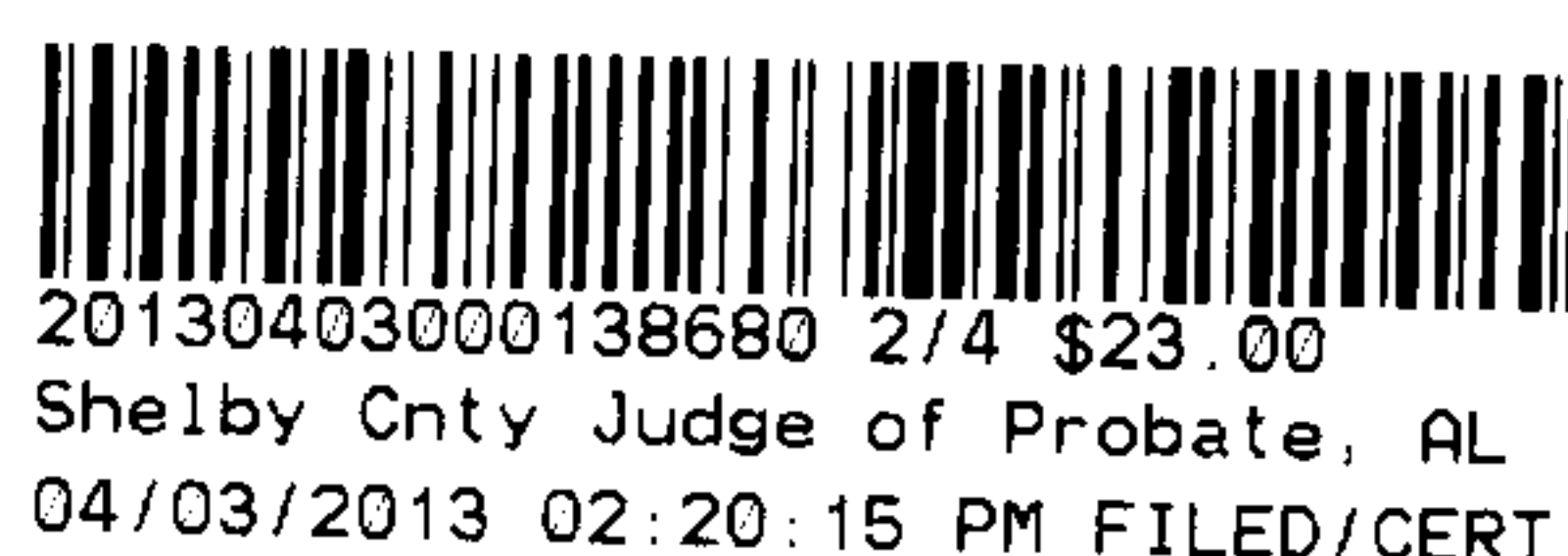
WHEREAS, David M. Sigler was the auctioneer and the person conducting the sale for said Wells Fargo Bank, NA; and
