\$91,920.00 of the purchase price herein above has been paid by a purchase money mortgage loan closed simultaneously herewith.

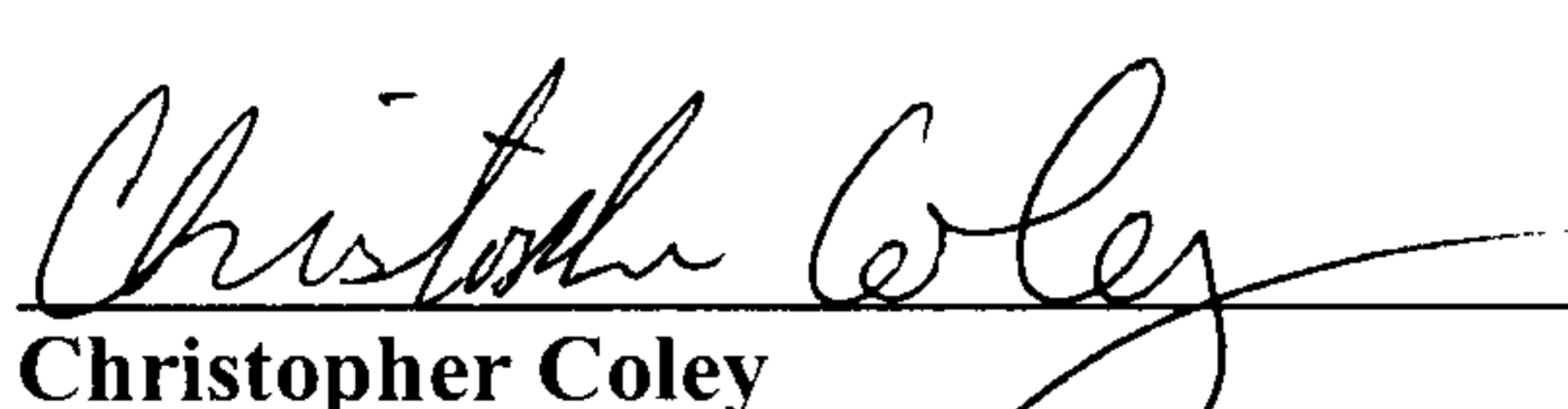
Samantha R. Bullock and Samantha Coley are one and the same person.

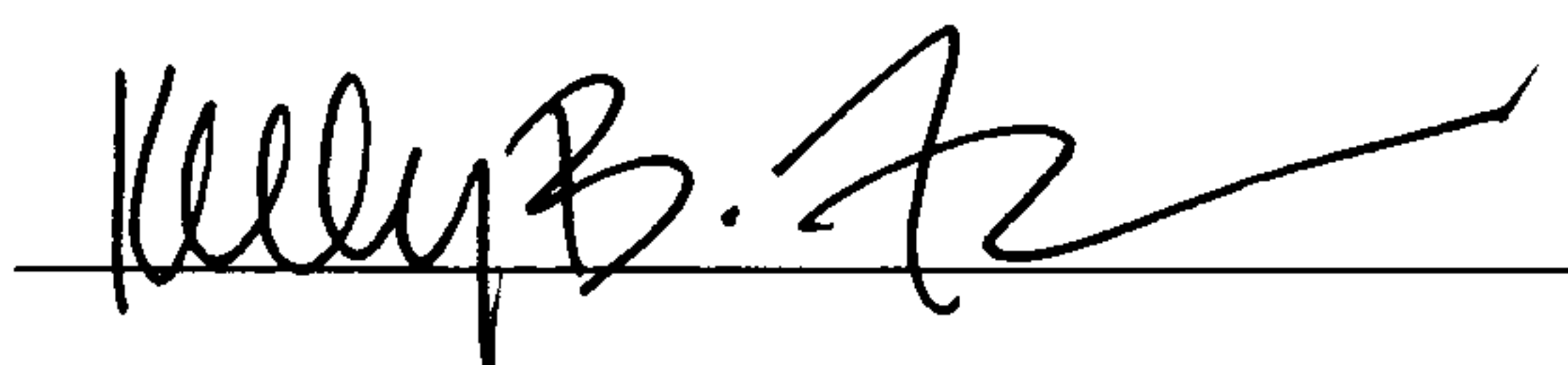
