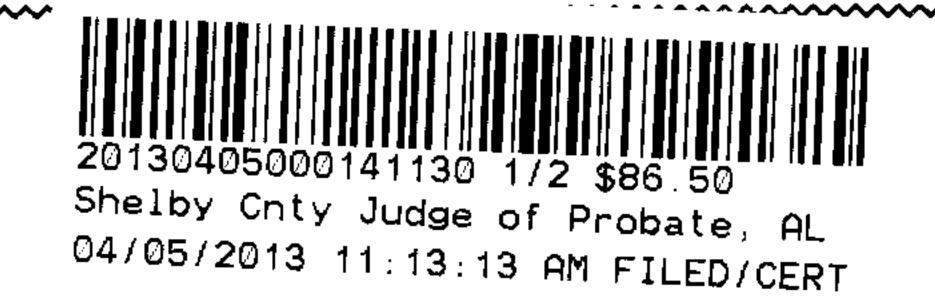

That in consideration of Two Hundred Thirty-Eight Thousand and 00/100 Dollars (\$238,000.00) and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt whereof is acknowledged,

Rusert Homes, LLC. (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Paul Eric Hillman and and Kristy Massey Hillman (herein referred to as GRANTEES, whether one or more), the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 4, according to the Survey of Chelsea Ridge Estates, 1st Sector, as recorded in Map Book 35, Page 150, in the Office of the Judge of Probate of Shelby County, Alabama.

Mineral and mining rights excepted. Subject to current taxes, easements, conditions, convenants, and restrictions of record. \$166,600.00 0 of the consideration was paid from a mortgage loan closed simultaneously herewith.

This covenant and agreement shall run with the land conveyed hereby as against Grantees, and all persons or entities holding under or through Grantees.

And Grantor does for itself and for its successors and assigns covenant with the said GRANTEES, their heirs and assigns, that it is lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that it has a good right to sell and convey the same as aforesaid; that it will and its successors and assigns shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
