

QUALIFIED DISCLAIMER

This Qualified Disclaimer is made by Betty Jo Allison ("Disclaimant"), the surviving spouse of George R. Allison, deceased ("Decedent"), and beneficiary of that certain trust described herein below. This disclaimer is being made pursuant to Section 2518 of the Internal Revenue Code of 1986, as amended and Section 31-1-103 of the Tennessee Code Annotated (2012),

WHEREAS, the late George R. Allison, who died on January 29, 2013, did specifically devise to the undersigned Disclaimant a certain interest in the property referenced in Article VII(B) of the George R. Allison Revocable Living Trust set out under the Second Amendment and Restatement of the George R. Allison Revocable Living Trust (dated February 13, 2007) and as last amended on February 9, 2012 (hereinafter referred to as "the Trust" and the same being incorporated herein, by reference, as if fully set out herein) and designated as the Marital Share and a property interest described in Article VII(C) of the Trust and designated as the Residuary Trust;

WHEREAS, the Decedent, then domiciled in the County of Shelby, State of Alabama, died testate on January 29, 2013. All the property made subject matter of this disclaimer was and is now owned by the Trust. The Trust became irrevocable at the date of the death of the Decedent pursuant to Article V of the Trust;

WHEREAS, less than nine (9) months have elapse since the date of Decedent's death;

WHEREAS, the Disclaimant has not heretofore received or accepted any property under the Trust;

WHEREAS, pursuant to Article XIX of the Trust, it is being governed and construed according to the laws of the State of Tennessee; and

WHEREAS, the Disclaimant desires to disclaim any and all interest that she may have in that certain property as designated for her under the Trust, and she herein asserts her irrevocable and unqualified refusal to accept any interest from the Trust, more particularly described above;

NOW, THEREFORE:

1. Declaration of Disclaimer and Extent Thereof.

I, Betty Jo Allison, the undersigned Disclaimant, being of sound mind and disposing memory and

over the age of twenty-one (21) years do hereby forever irrevocably and unqualifiedly disclaim, relinquish,

surrender and release any and all interest that I may have in the Residuary Trust held under Article VII

(C) of the Trust and any and all property designated for me in Article VII(B) Marital Share of the Trust

(hereinafter "Disclaimed Property"), whether such interest be present or future, vested or contingent, in

and to said property.

I hereby voluntarily and freely disclaim my interest in the Disclaimed Property to the fullest extent

possible. I have not accepted any interest in or benefit from the Disclaimed Property and will not receive

any consideration for making this Disclaimer.

acknowledge that the Disclaimed Property will pass to persons other than me and without any

direction on my part in the same manner as if I had predeceased my spouse, George R. Allison.

2. Intent to be a Qualified Disclaimer. Delivery and Timing of Disclaimer.

It is my intention that this be a qualified disclaimer under the provisions of the Section 2518 of the

Internal Revenue Code of 1986, as amended and pursuant to T.C.A. §31-1-103. This disclaimer is timely

made and presented to the proper person and (recorded in the appropriate court clerk's office so that this

disclaimer will be of record). I have not waived and am not barred from exercising my rights to disclaim

the Disclaimed Property.
