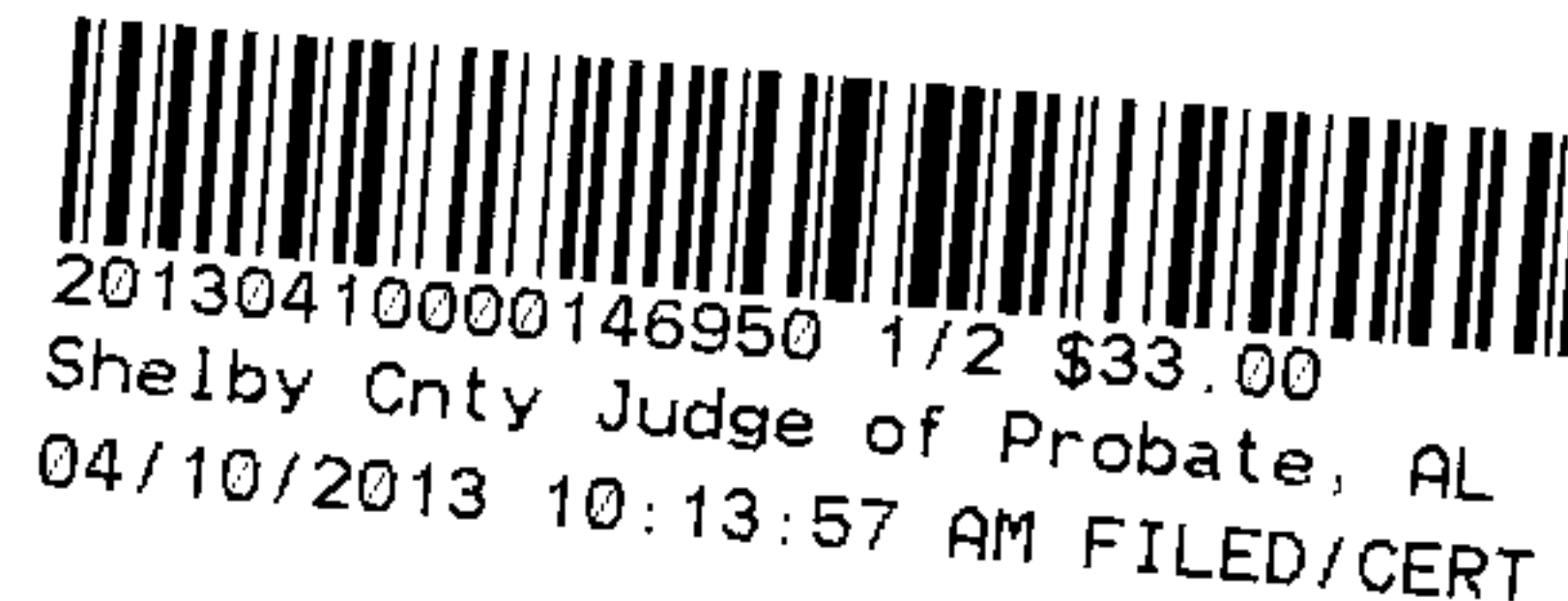

## POWER OF ATTORNEY

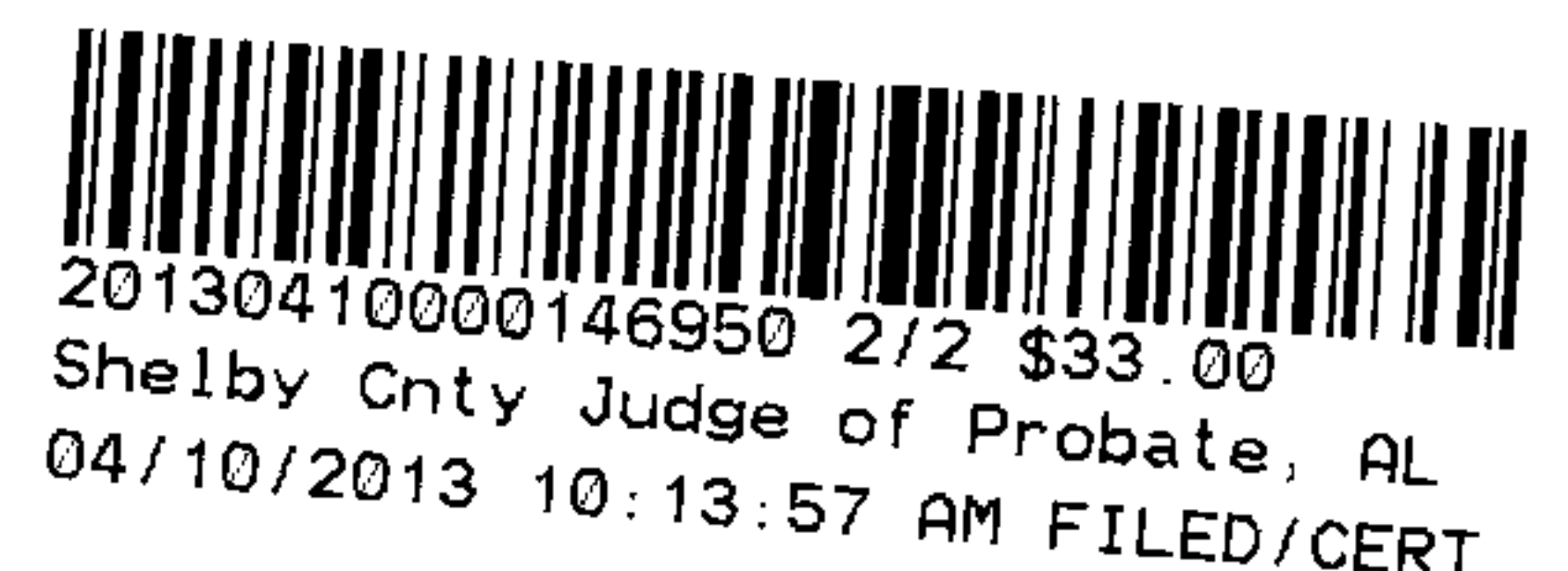

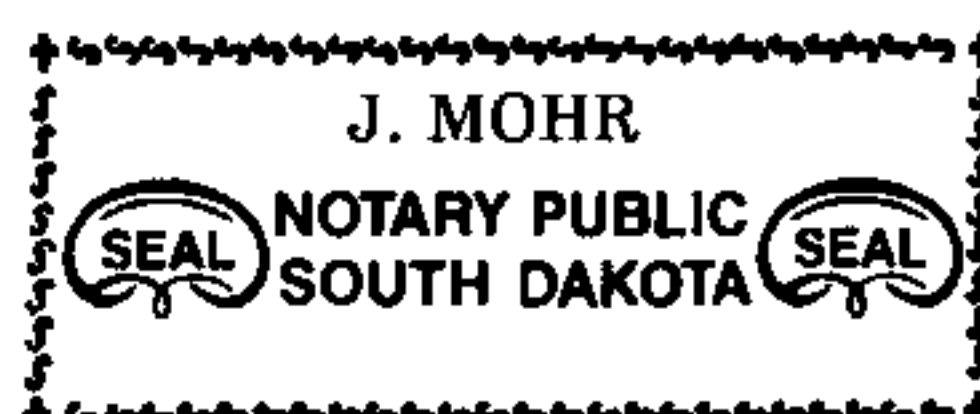
