# SPECIAL WARRANTY DEED

SHELBY COUNTY

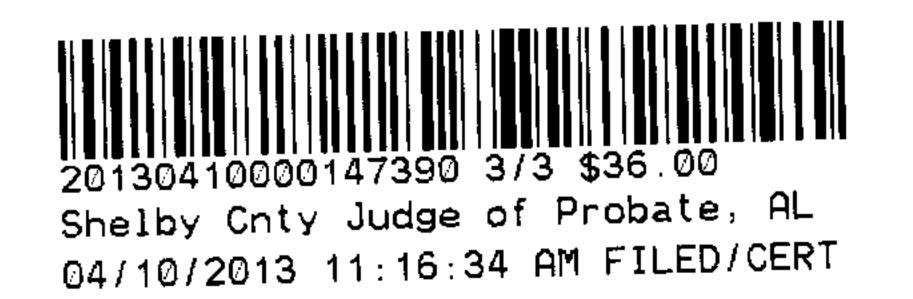
