## NOTICE OF EXTENSION OF COAL SEAM GAS LEASE

WHEREAS, USS conveyed the coal seam gas described in the Coal Seam Gas Lease to RGGS Land & Minerals, Ltd., L.P., a Delaware limited partnership ("RGGS"), and assigned the Coal Seam Gas Lease to RGGS effective as of February 26, 2004; and

WHEREAS GeoMet recorded a Notice of Extension of Coal Seam Gas Lease in the Probate Office of Shelby County, Alabama on April 29, 2004 as Instrument No. 20040429000224120 stating that Paragraph 2 of the Lease addressed extension of the Lease and that GeoMet had complied with the provisions of Paragraph 2 resulting in the extension of the primary term for an additional four (4) years, with the effect of the primary term of the Lease being extended to April 8, 2006; and

WHEREAS GeoMet has made all revenue payments necessary to maintain the lease in full force since April 8, 2006 and has otherwise complied with the provisions of Paragraph 2 of the Lease and GeoMet has secured agreement from RGGS for the primary term of said Lease to be further extended, with the expiration of the primary term of said Lease now being April 8, 2014.

NOW THEREFORE, GeoMet files this Notice in the Probate Records of Shelby County, Alabama to place the public on notice of the extension of the Lease.


