

## FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on August 4, 2010, to-wit: Christopher A. Glass and Caitlin Glass, as husband and wife, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as a nominee for First Federal Bank, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on 8/18/2010, in Instrument Number 20100818000264930, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, N.A., by assignment recorded January 23, 2013, and recorded in Instrument Number 20130123000029520, Probate Records of Shelby County, Alabama; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and thereafter notice was published in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on February 20, 2013, February 27, 2013, and March 6, 2013, that the hereinafter described property would be sold at the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on March 19, 2013, and

WHEREAS, the said sale was held at the time and place stated in said notice, in strict conformity with the powers of sale contained in the said mortgage, at which sale JPMorgan Chase Bank, N.A., became the purchaser of the hereinafter described property at and for the sum of \$54,315.00, cash, which was the highest, best, and last bid therefore; and
