FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on August 4, 2010, to-wit: Christopher A. Glass and Caitlin Glass, as husband and wife, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as a nominee for First Federal Bank, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on 8/18/2010, in Instrument Number 20100818000264930, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, N.A., by assignment recorded January 23, 2013, and recorded in Instrument Number 20130123000029520, Probate Records of Shelby County, Alabama; and


