The undersigned organizer, intending to organize a limited liability company under the Alabama Limited Liability Company Act, Title 10, Chapter 12, *Code of Alabama* (1975), as the same may be amended from time to time (the "Act"), hereby adopts the following Articles of Organization:

***ARTICLE I:*
NAME**

The name of the limited liability company shall be Crossroad Striping, LLC (the "company") and the address of the principal place of business of the company is 429 Bentmoor Way, Helena, Alabama 35080.

***ARTICLE II:*
DURATION**

The duration of the company is perpetual.

***ARTICLE III:*

The management of the company shall be by the two members.

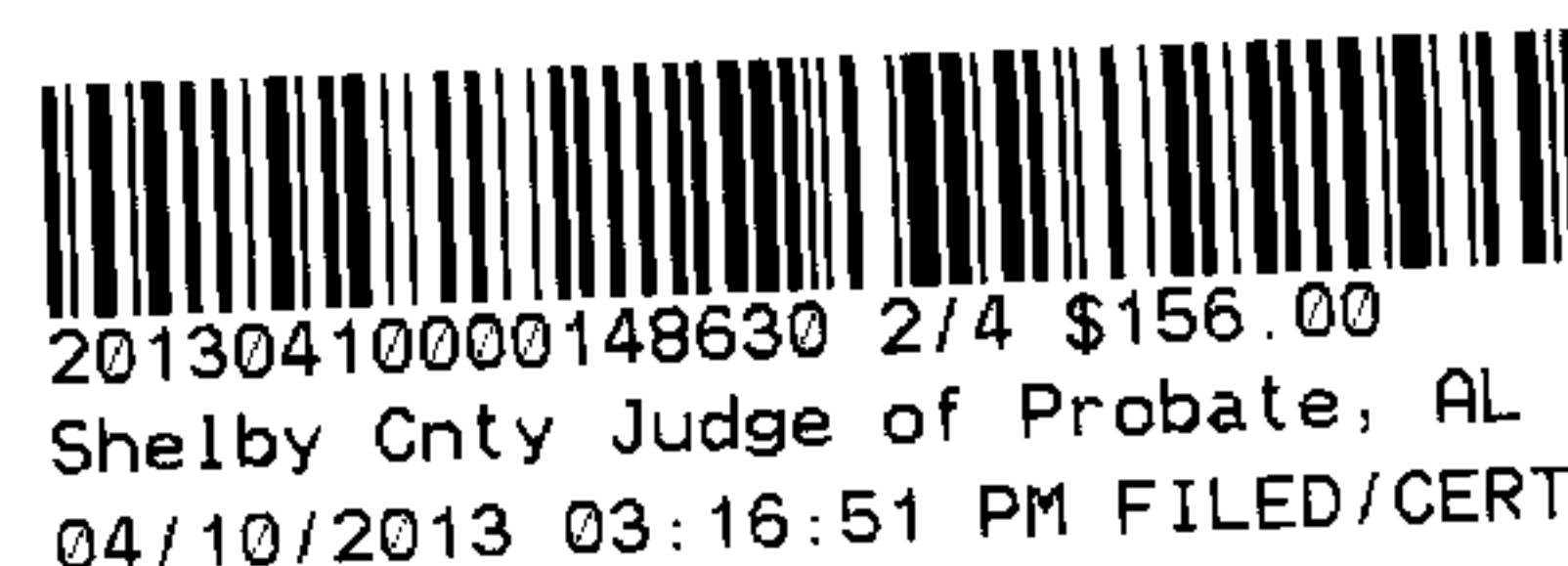
ARTICLE VII:


ARTICLE VIII:
ADDITIONAL MEMBERS


