GENERAL WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of **One Hundred Seven Thousand and NO/100 Dollars (\$107,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Tawny L. Stephens and David M. Stephens, wife and husband

(herein referred to as Grantors), grant, bargain, sell and convey unto

Jared J. Yarchak and Laney M. Yarchak

(herein referred to as **Grantees**), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama to wit:

Lot 43, according to the Survey of Final Plat of Park Forest Village as recorded in Map Book 31, Page 51, Shelby County, Alabama Records.

Subject to easements, rights of way, set back lines, restrictions, covenants, mineral and mining rights not owned by the grantors and current taxes due.

\$105,061.00 of the above consideration was secured by and through the purchase money mortgages closed and recorded herewith.

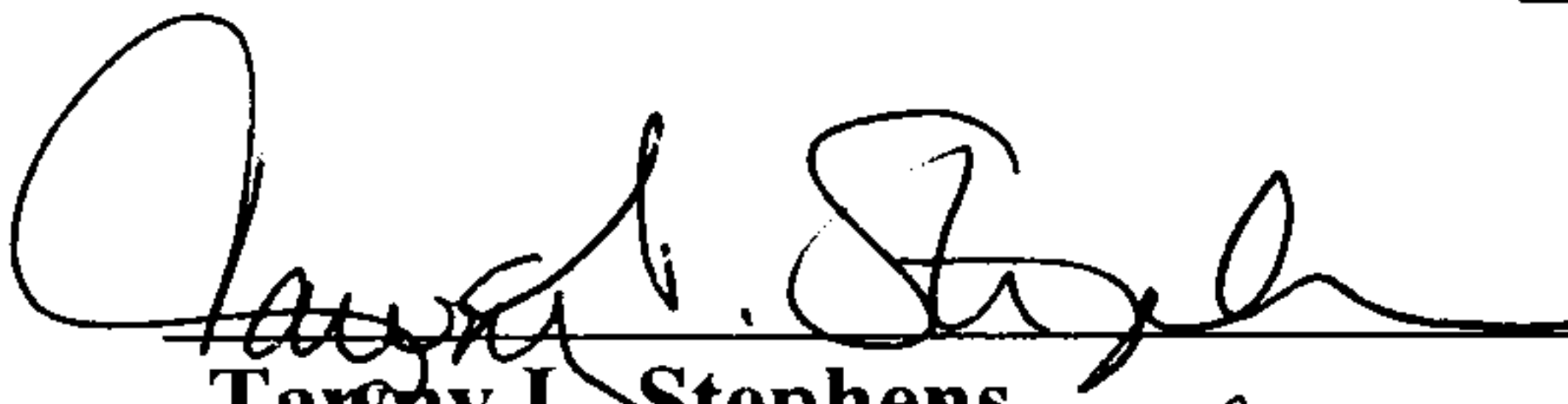
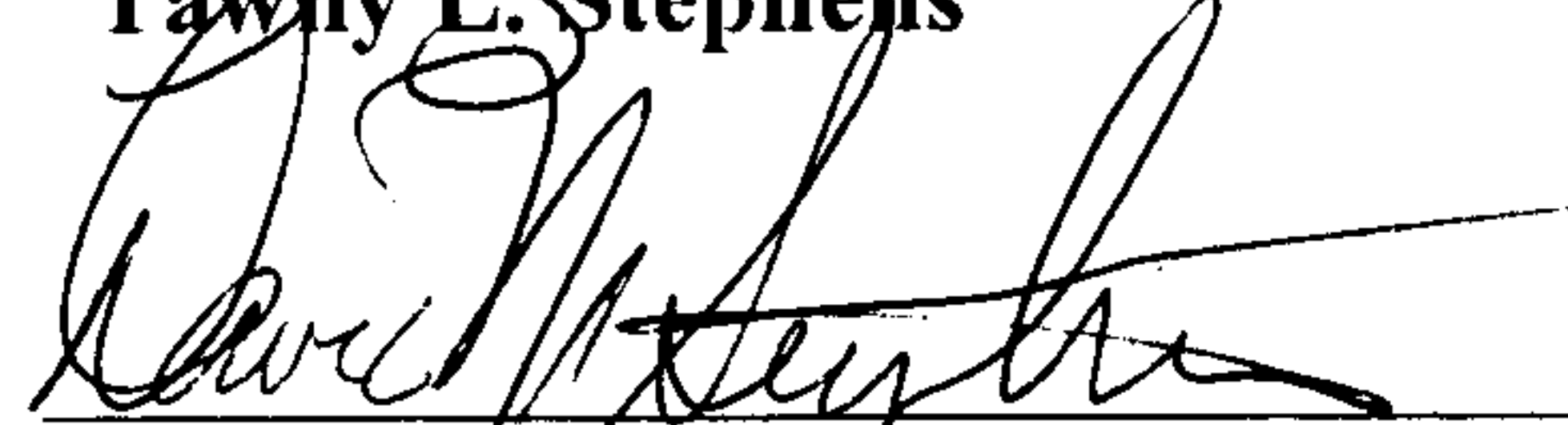
