FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on January 28, 2012, to-wit: Pamela J. Williams fka Pamela J. Ingels and Dolan Williams, husband and wife, executed a mortgage to JPMorgan Chase Bank, N.A., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on February 10, 2012, in Instrument Number 20120210000051260, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; and
