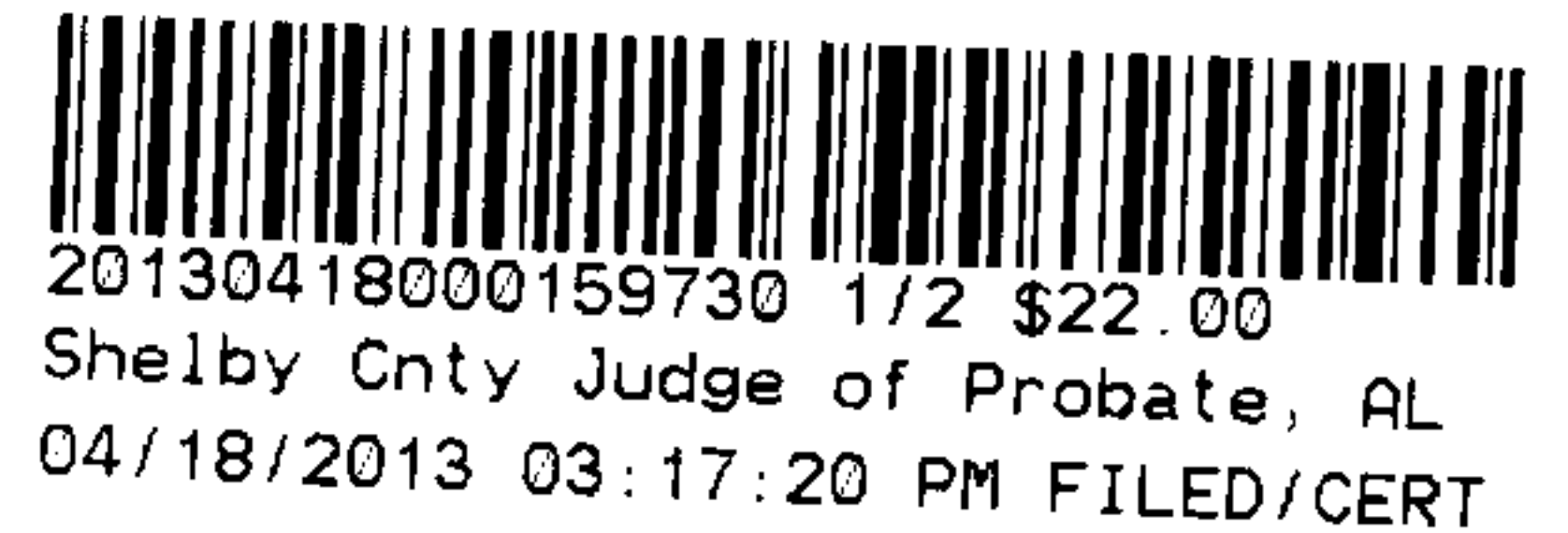

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Two Hundred Twenty-One Thousand Five Hundred and 00/100 (\$221,500.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **Ronald Graley and Shela Graley, HUSBAND AND WIFE** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Nathanial D. Hall and Carrie R. Hall**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 85, according to the Subdivision Plat map of Wynlake, Phase 4 C, as recorded in Map Book 29, page 15, in the Office of the Judge of Probate of Shelby County, Alabama.

\$214,855.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.






