FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on November 22, 2005, to-wit: David J. Sharpe and Tami B. Sharpe, husband and wife, executed a mortgage to ABN Amro Mortgage Group, Inc., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on November 30, 2005, in Document Number 20051130000618020, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; and

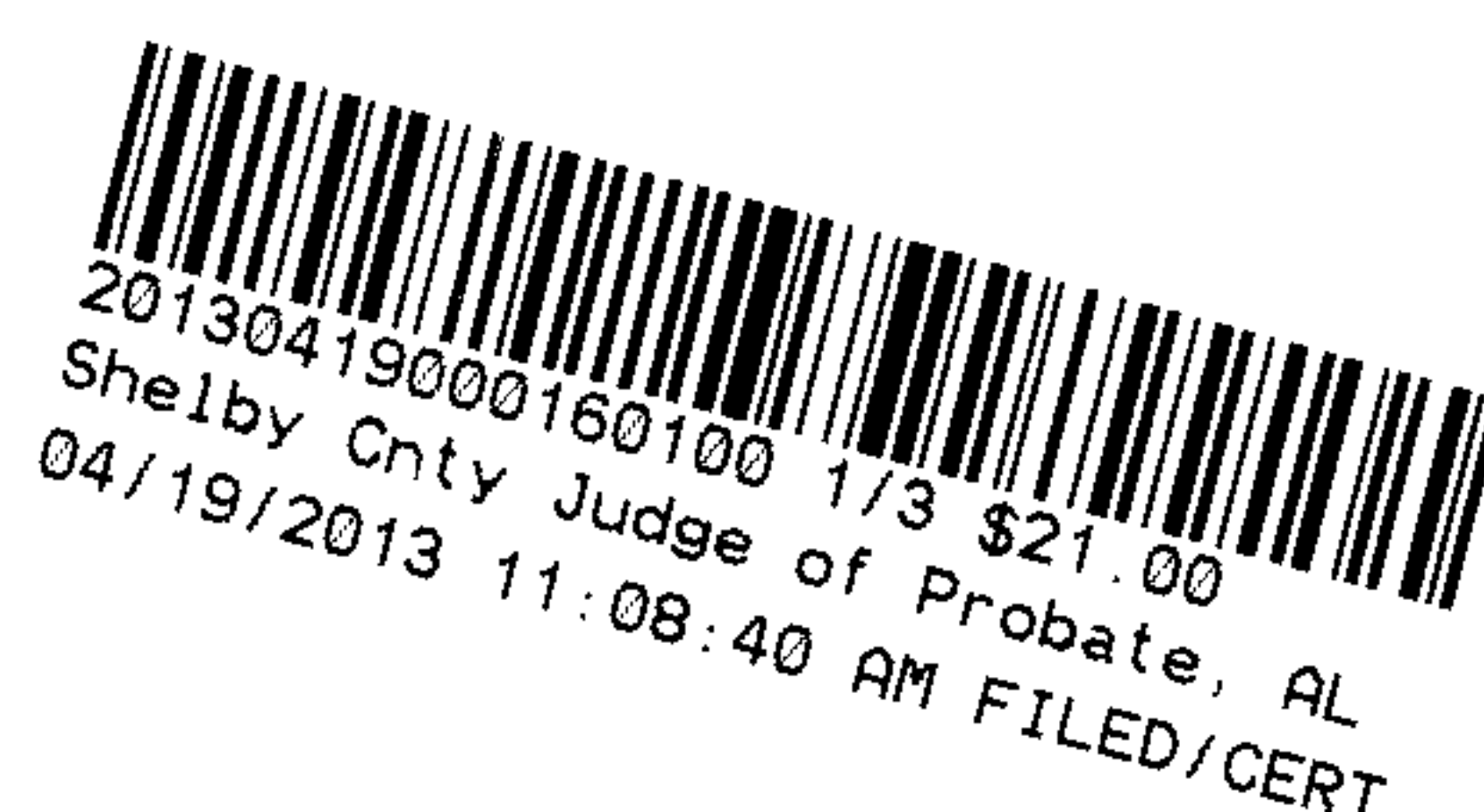



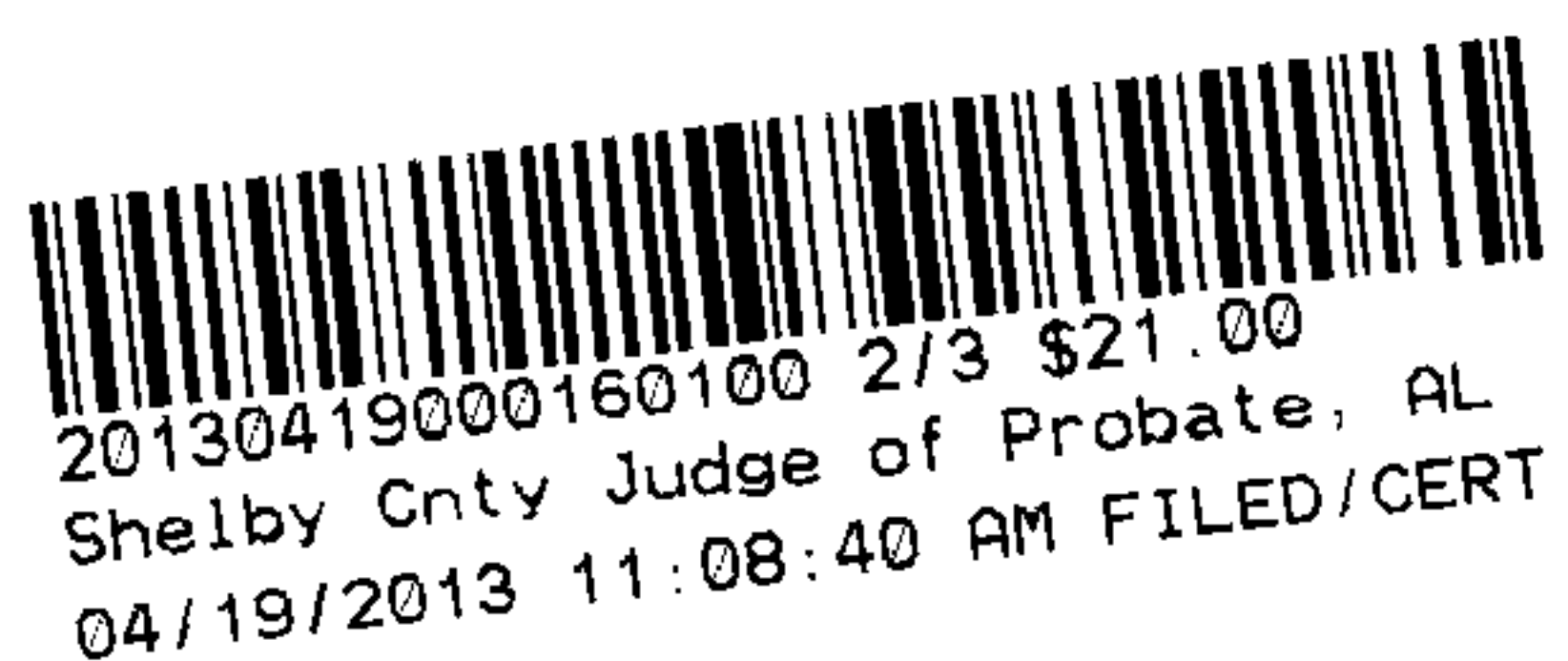
