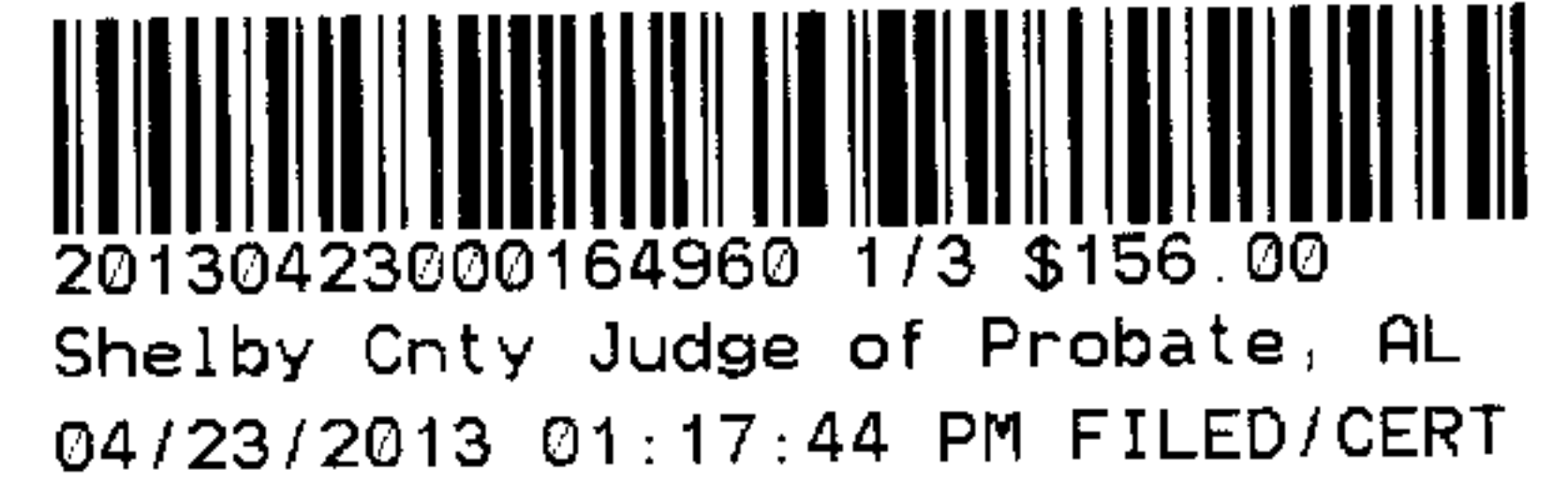


**ARTICLES OF ORGANIZATION OF
JIM LEVINSON CONSULTING, LLC**



I the undersigned natural person of age eighteen years or more, acting as organizer of a limited liability company under the Limited Liability Company Act of the State of Alabama, hereby adopt the following Articles of Organization for the limited liability company:

ARTICLE ONE

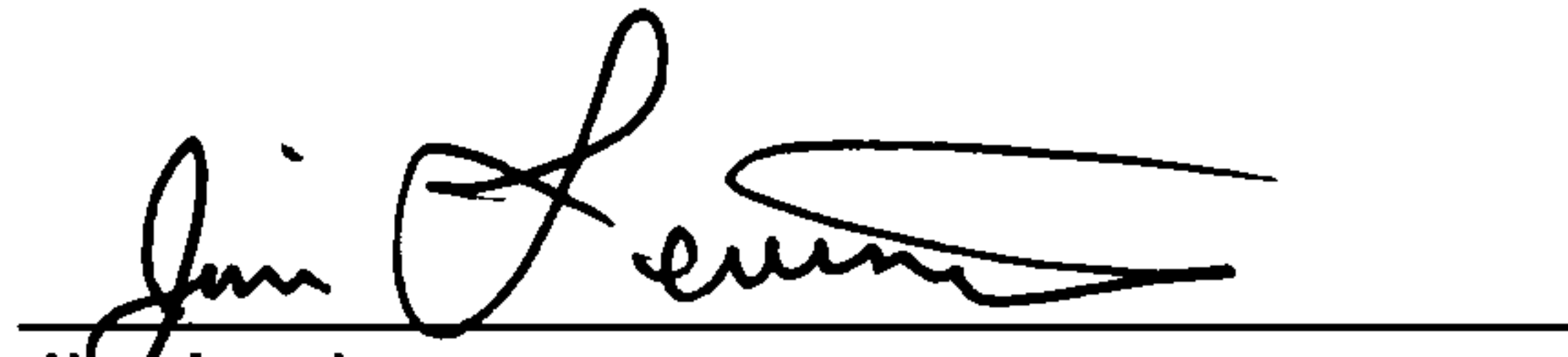
ARTICLE EIGHT
