**ARTICLES OF ORGANIZATION
OF
BADOLATO HOLDINGS, L.L.C.**

We, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1. The name of the Limited Liability Company is BADOLATO HOLDINGS, L.L.C.
2. The period of its duration is perpetual.
3. The purpose for which this limited Liability Company is organized:

To engage in the transaction of any or all lawful business for which limited liability companies may be organized under the laws of the State of Alabama, including, without limitation, the purchase, management and sale of real property.

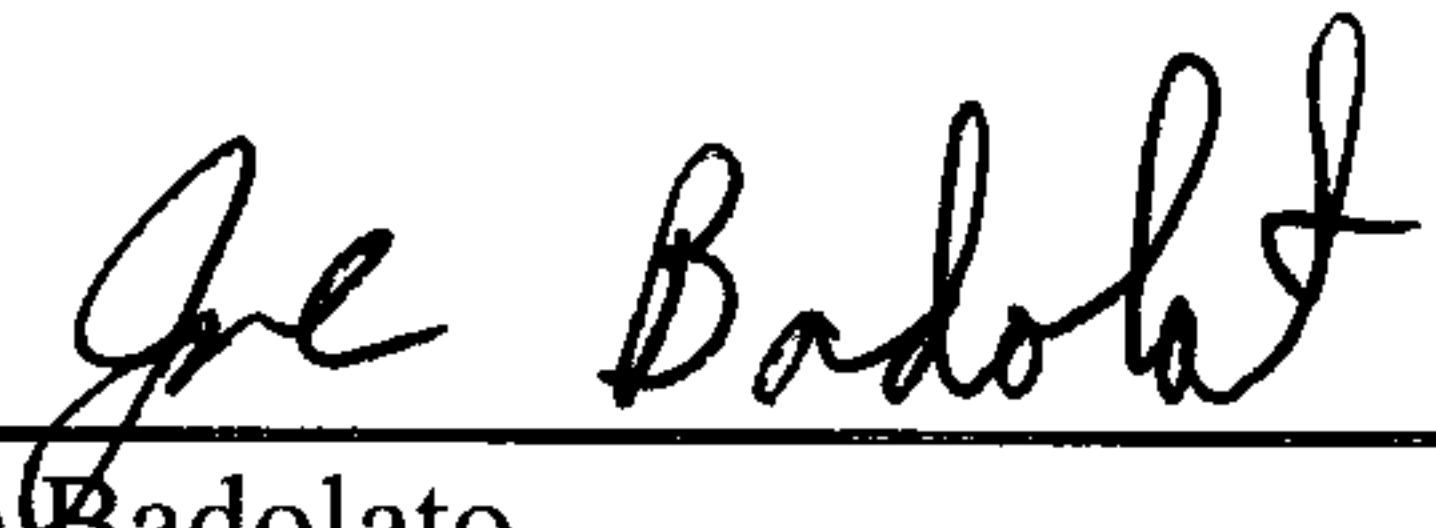
4. The location and mailing address of the initial registered office shall be: 1012 Royal Mile, Birmingham, AL 35242, and the name of the initial registered agent at said address shall be _Joe Badolato.

6. The members of the Limited Liability Company shall have the right to admit additional members to the Limited Liability Company upon the consent of the members of the Limited Liability Company holding a majority of the membership interests in the Limited Liability Company.
7. The Limited Liability Company will be dissolved if there is no remaining member, unless either of the following applies; (i) the holders of all the economic interests of the Limited Liability Company agree in writing, within 90 days after the cessation of membership of the last member, to continue the legal existence and business of the company and to appoint one or more members; or (ii) the legal existence and business of the company are continued and one or more new members are appointed.

8. The Limited Liability Company shall be managed by its members.
9. The regulation of the internal affairs of the Limited Liability Company, if not set forth herein, shall be governed by the Operating Agreement of the Limited Liability Company which may be in effect from time to time.
10. The filing of the limited liability company is effective immediately on the date filed by the judge of probate.
11. For tax purposes the LLC elects to be taxed as an S-Corporation under the Internal Revenue Code.
