FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on September 13, 2002, to-wit: Gathel Runnels and Cindy Runnels, husband and wife, executed a mortgage to ABN Amro Mortgage Group, Inc., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on October 1, 2002, in Instrument Number 20021001000474640, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; and



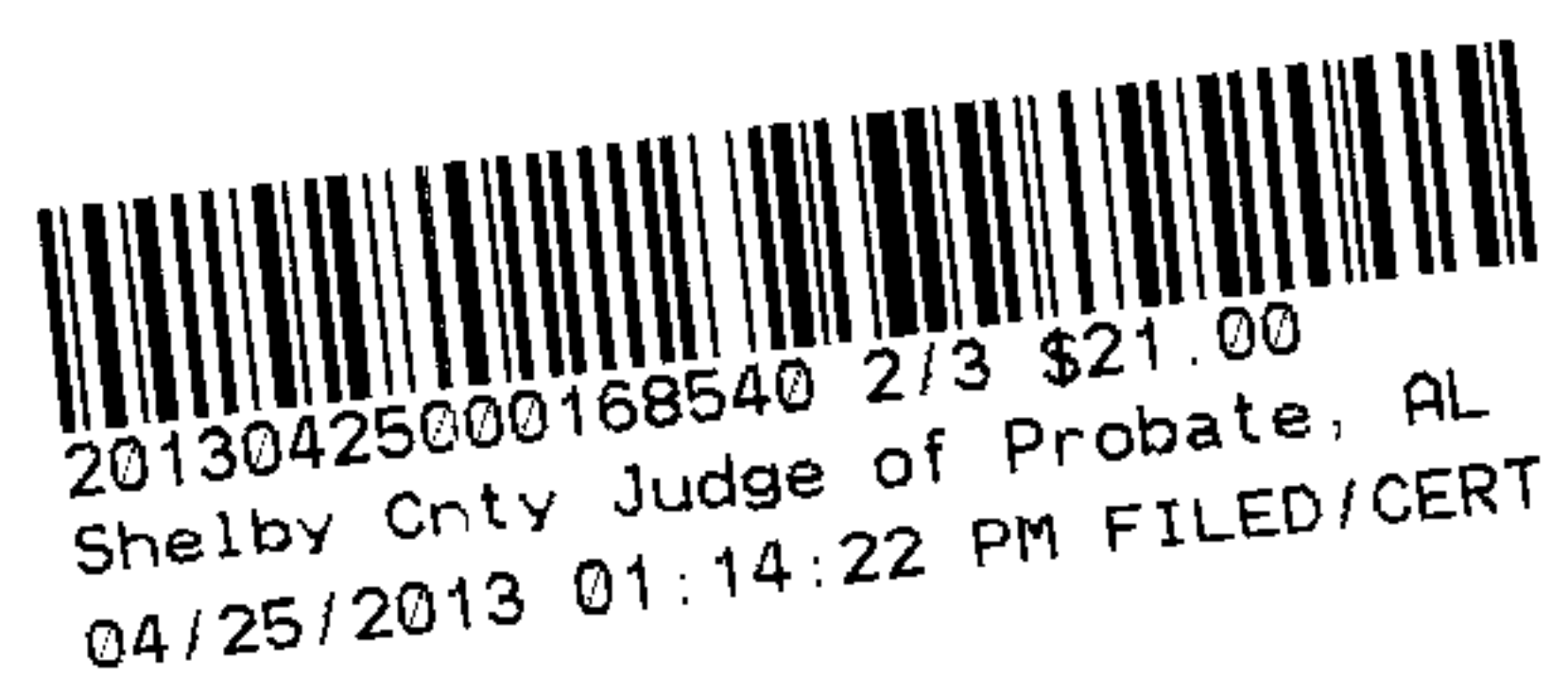
