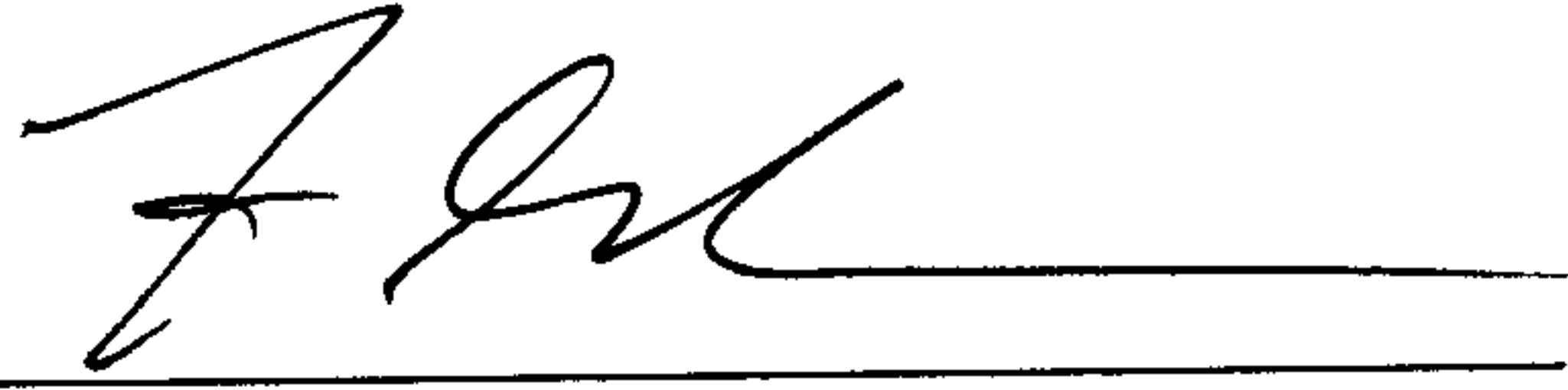
PRO TANTO RELEASE OF RECORDED JUDGMENT AS TO WILLEM NOLTES
