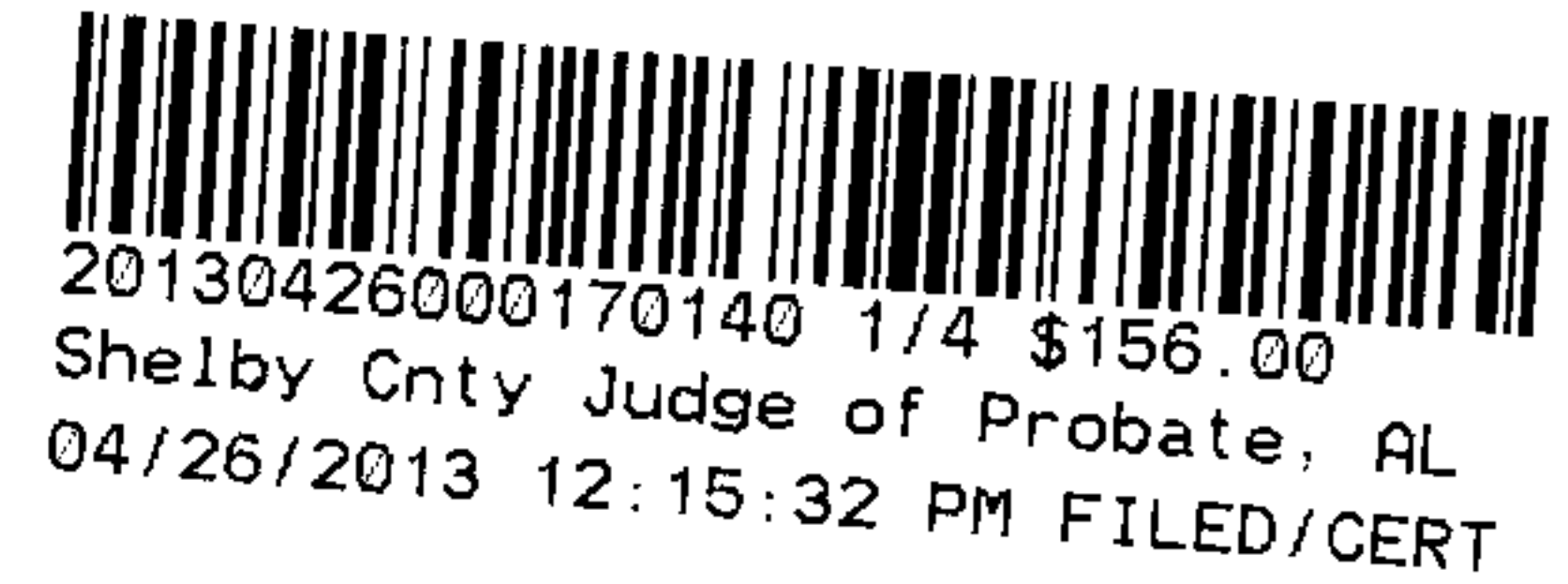


**CERTIFICATE OF FORMATION
OF
LOULOU ONE, LLC**



1. The name of the limited liability company is LOULOU ONE, LLC, hereinafter referred to in this Certificate of Formation as the "Company."

2. The period of its duration is perpetual.

3. 8. Management of the Company shall be vested in one or more managers. There shall be one (1) initial manager of the Company, and the name and address of the individual who is to serve as such initial manager until her successor is elected and begins serving is as follows:

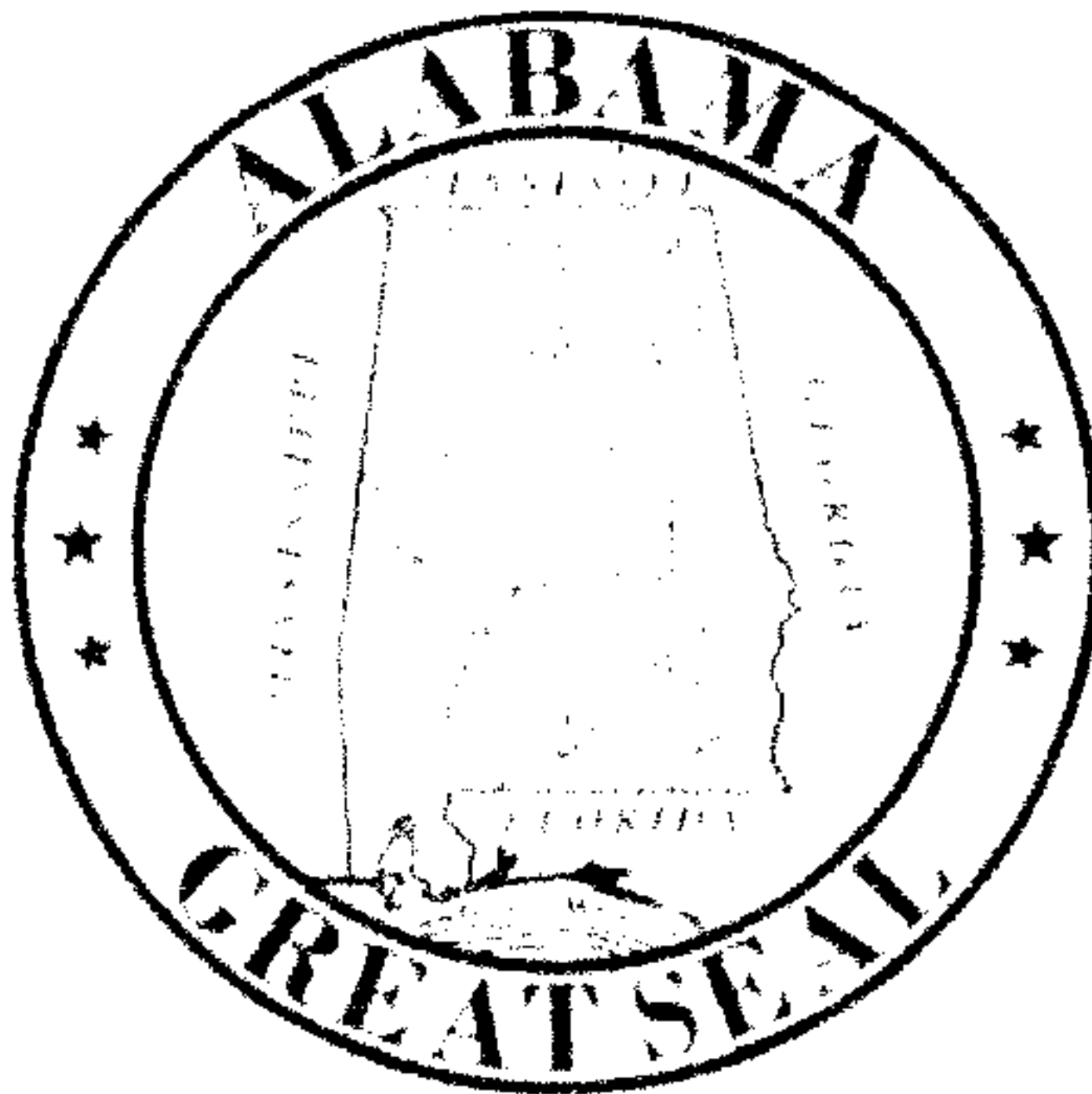
