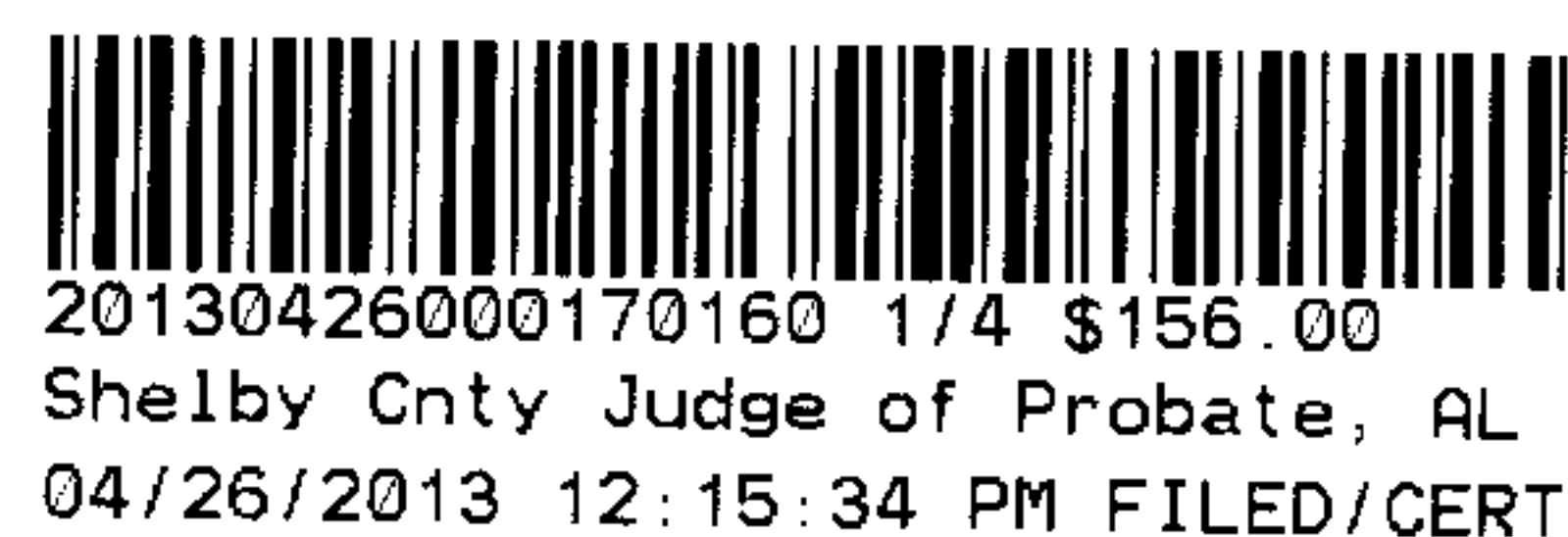


**CERTIFICATE OF FORMATION
OF
WILLREN, LLC**



1. The name of the limited liability company is Willren, LLC, hereinafter referred to in this Certificate of Formation as the "Company."

2. The period of its duration is perpetual.

3. The purpose for which the Company is organized is the transaction of any and all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Company Law, including, without limitation, engaging in the business of owning real property and all activities incidental thereto.

8. Management of the Company shall be vested in one or more managers. There shall be one (1) initial manager of the Company, and the name and address of the individual who is to serve as such initial manager until her successor is elected and begins serving is as follows:

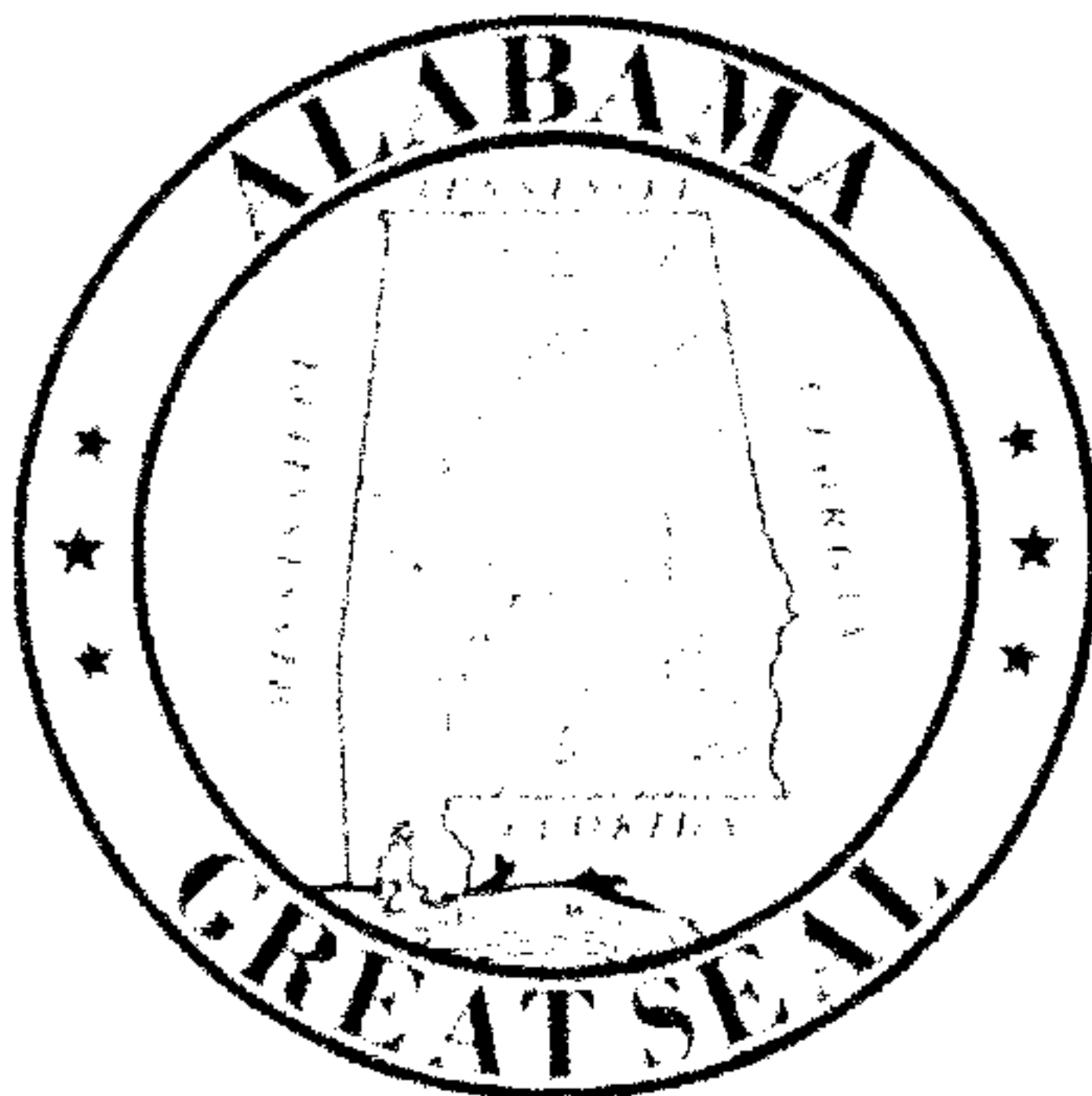
