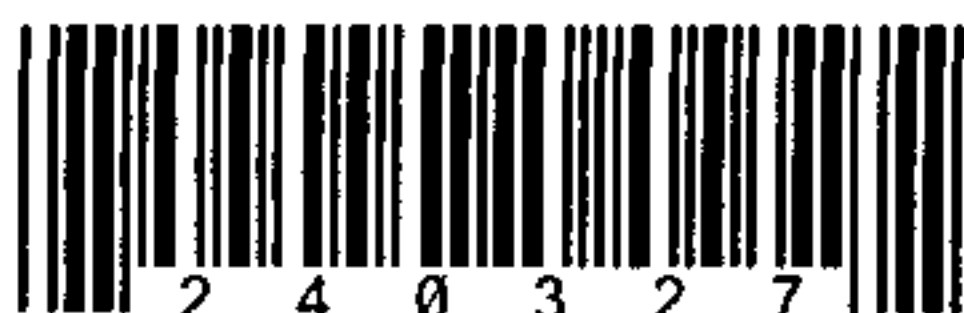
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of May, 1998, John R. McCain, III and wife Traci McCain, executed that certain mortgage on real property hereinafter described to South States Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 1998-21875, said mortgage having subsequently been transferred and assigned to Chase Manhattan Mortgage Corporation, by instrument recorded in Instrument Number 1998-21876, in the aforesaid Probate Office ("Transferee"); and

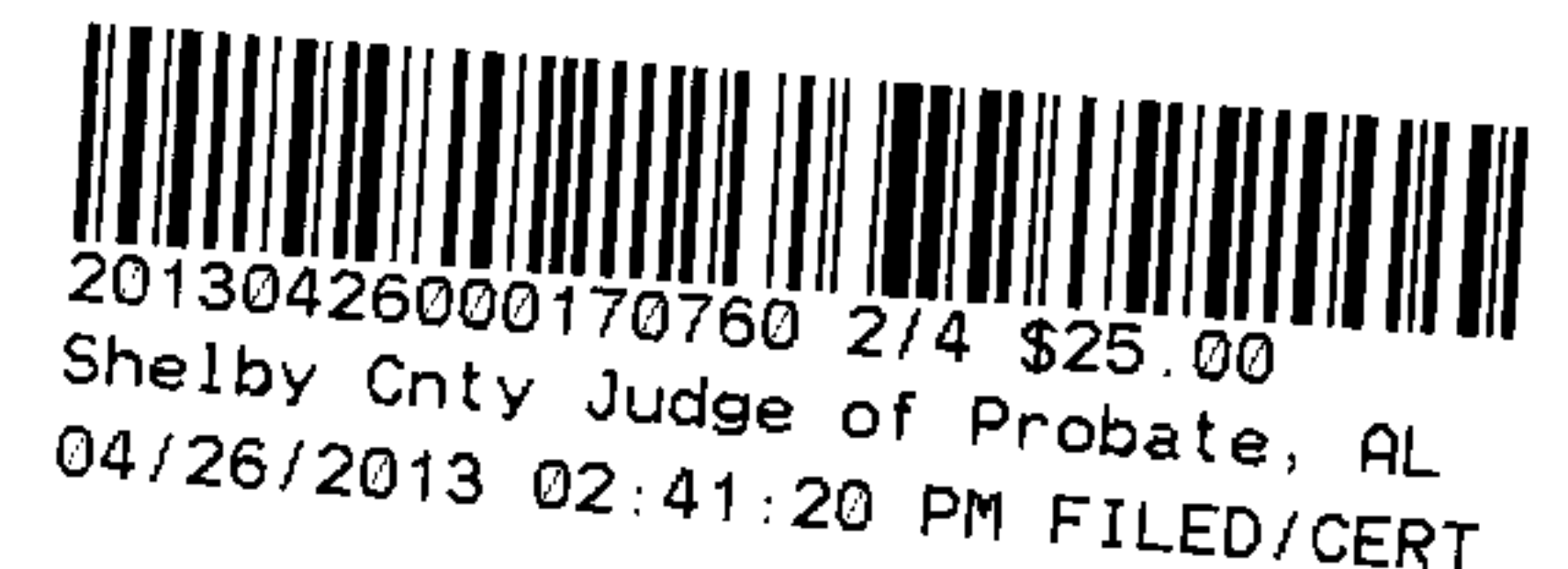

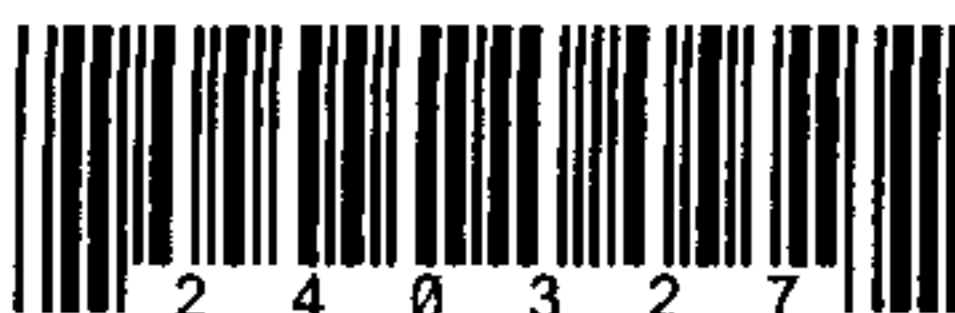
